- c. The merit list shall be drawn up on the basis of weighted of marks obtain in all the 6 categories mentioned in the table above. In case more than candidate has equal marks,the candidate with past experience of working in child rights will be given preference. The decision of the Selection Committee in this regard shall be final.
- d. The Selection Committee shall make and recommend the name of 5 candidates for eachposition in order of preference to the Governing Body/Management of the institution forappointment against vacant positions. The candidates scoring the highest mark will becalled for a verification of certificates prior to issue of appointment order. The panel listwill be valid for 1 year from the date of finalization.
- e. Finalize merit list as per advertisement will be send through valid Email Id of candidates.
- f. Any joining or exit of employees of or above the qualification of postgraduation position shall be done with the prior approval of the concerned District Magistrate and Collector.
