- 1. Interested candidates having the requisite qualification and experience may appear for registration on date as mentioned against each post. The registration timing is from 10. 30 am to 12 noon only No application will be received after scheduled timing of registration After registration candidates will be shortlisted on the basis of required eligibility criteria and shortlisted candidates will be asked to stay back for interview. Candidates not fulfilling the eligibility criteria in this advertisement need not come for the interview.

- Candidates are required to come .for interview with duly filled in application in prescribed format available in district website https://deogarh.odisha.gov.in/and bring all certificates testimonials in original and a set of self-attested photocopies of the same in support of age, qualification and experience for verification.
- 4. Candidates are also required to bring two recent passport size photograph, and self-photo id proof (Aadhar card, PAN card, DL, Voter Id, and Passport....ctc).

- 7. In case the marks obtained are in the form of CGPA/ OGPA/ DGPA/ GPA/ CPI etc., a certificate for conversion as applicable to percentage of marks shall be submitted at the time of submission of application form if it is not mentioned in the mark sheet itself, otherwise the same will be rejected.
- 8. The above positions are purely temporary (i.e. contractual in nature for a period of 11 months, which can be extended depending upon requirement and suitability) and Co terminus with scheme. Canvassing in any form will render the candidate disqualified for the position.

Candidates, who are already working in Health Department the age relaxation to the employees for the post applied shall be allowed @ 1(one) per year for each contractual term of service up to maximum age limit prescribed in the Advertisement of the said post, subject to an age ceiling of 55 years.
