# Eligibility, Application Requirements and Remuneration (For Teaching Positions)

1. Name of the Position: Associate Professor

No. of Positions: Variable

Remuneration: Negotiable based on the candidate's qualifications and experience.

#### Eligibility:

- (i) Candidates must possess a good academic record and hold a Ph.D. degree in the concerned, allied, or relevant discipline.
- (ii) A Master's degree with at least 55% marks (or an equivalent grade on a point scale, wherever applicable) is required.
- (iii) A minimum of eight years of experience in teaching and/or research in an academic or research position equivalent to that of Assistant Professor in a University, Accredited Research Institution, or Industry is required. The candidate must have a minimum of seven publications in peer-reviewed or UGC-listed journals, along with a total research score of seventy-five (75) as per the criteria specified in Appendix II, Table 2 of the UGC Regulations, 2018.

2. Name of the Position: Assistant Professor

No. of Positions: Variable

Remuneration: Negotiable based on the candidate's qualifications and experience.

#### Eligibility

- (i) The candidate must possess a Master's degree with at least 55% marks (or an equivalent grade on a point scale wherever applicable) in the concerned, relevant, or allied discipline from a recognized Indian university, or an equivalent degree from an accredited foreign university.
- (ii) In addition, the candidate must have qualified the National Eligibility Test (NET) conducted by the UGC or the CSIR, or an equivalent test accredited by the UGC such as SLET/SET.

Or

Candidates who have been awarded a Ph.D. degree in accordance with the UGC Regulations (Minimum Standards and Procedure for Award of Ph.D. Degree), 2009 or 2016, including any subsequent amendments, shall be exempted from the requirement of qualifying NET/SLET/SET.

However, the candidates registered for the Ph.D. programme prior to 11th July 2009, shall be governed by the provisions of the then existing Ordinances/ Bye-laws/ Regulations of the

Institution awarding the degree, and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for appointment of Assistant Professor subject to the fulfillment of the following criteria:

- (a) The candidate's Ph.D. degree must have been awarded through a regular mode of study.
- (b) The Ph.D. thesis must have been evaluated by a minimum of two external examiners.
- (c) The candidate must have successfully undergone an open Ph.D. viva voce examination.
- (d) The candidates must have published at least two research papers based on their Ph.D. work, with at least one paper published in a refereed journal.
- (e) The candidates must have presented at least two papers based on their Ph.D. work at conferences or seminars sponsored, funded, or supported by the UGC, ICSSR, CSIR, or any analogous agency.

The fulfillment of these criteria is to be certified by the Registrar or the Dean (Academic Affairs) of the University or academic institute concerned.

- 4. Teaching experience certificates issued from the appropriate authority.
