## Tenure:

The Selected Candidate shall be initially engaged for a period of six months which may be extended upto a maximum of 3 years depending on his/her performance and requirement of the Institute as per the Institute norms.

### **Terms and Conditions:**

1. Final selection of the candidates will be based on their academic and professional background and performance in the presentation followed by interview.
2. The candidates should possess degrees from any recognized University/Institute.
3. Mere eligibility does not vest any right on any candidate for being called for an interview/selection. The decision of the Institute in all matters will be final.
4. In addition to his/her academic assignments, the Contractual Faculty has to perform other duties and activities assigned by the competent authority.
5. The rules and conditions governing the number of teaching days and workload shall be as prescribed by the Institute from time to time. Contractual Faculty shall attend office on all working days as notified by the Institute to accomplish the tasks assigned.
6. The Contractual Faculty shall be bound to act in conformity with the Statutes, Ordinances, Regulations, and Rules of the Institute.
7. The payment of taxes including income tax will be the sole responsibility of the contractual faculty. However, tax reduction at source will be effected against the payable remuneration at applicable rates as per the prevailing laws, rules, and regulations.
8. On campus residential accommodation may be provided as per the rules and regulations of the Institute, subject to availability.
9. The Institute reserves the right to withdraw any or all the posts advertised.

**Performance Assessment during the Tenure:**

1. The Contractual Faculty will confirm to all the rules and regulations of the institute governing the services of its employees.
2. The performance of the Contractual Faculty will be assessed by a committee constituted by the Institute.
3. The subsequent extension of tenure will be based on the recommendation of the committee on his/her performance and requirement of the Institute.
