

The application form need to be downloaded at [www.jagatsinghpur.odisha.gov.in](http://www.jagatsinghpur.odisha.gov.in) and filled in application form along with the color passport size photograph, self attested photocopy of all relevant certificate and mark sheets shall be submitted by the applicant at the time of registration.
5. Incomplete application in any form will be rejected.
6. In case the examination on the scheduled date cannot be conducted the same shall be held on the next working day.
7. Selection will be done as per the guideline stipulated by Mission Director, NHM, Odisha
8. Interested candidates fulfilling the eligibility criteria are to attend the Walk-In-Interview in the Office of the CDM & PHO-Cum-DMD, Jagatsinghpur by downloading the application form from the website [www.jagatsinghpur.odisha.gov.in](http://www.jagatsinghpur.odisha.gov.in). The filled in the application duly signed by the candidate along with self attested copies of all supportive documents shall however be submitted at the time of Walk-In-Interview.
9. In case the marks obtained are in the form of CGPA, OGPA, DGPA, GPA, CPI etc, a certificate for conversion as applicable to percentage of marks shall be submitted at the time of submission of application form, Otherwise the same will be rejected.
10. Underage/Overage, under qualification and short of requisite percentage of marks in the prescribed educational qualification shall be rejected.

If any candidate is found to have suppressed any material information or furnished false information / documents, his/her case shall not be considered for the post applied for and in case already engaged on the basis of the said information / documents, his/her service shall be terminated from the society forthwith.
