## **ADVERTISEMENT FOR FILLING UP OF POSTS OF SENIOR RESIDENTS AND TUTOR IN GMCH PHULBANI AND PMP MCH TALCHER.**

Eligible candidates are invited for **walk-in interview** for selection of the posts of Senior Residents (SR) & Tutors in different disciplines in GMCH PHULBANI PMPMCH Talcher of the State. The applicant must have acquired the required qualification for the post applied for on or before the date of counseling. The engagement shall be purely temporary for a period of one year. The posts are non-practicing. The in-service candidates who are selected as SR, will be entitled to draw their usual salary and the direct candidates will be paid consolidated amount as notified by Govt from time to time. Any additional incentive declared by the Government of Odisha for these posts shall also be applicable. The direct candidate having MBBS qualification can apply for the post of Tutor. Eligibility of application will be guided as per the provisions mentioned here under:

### **1. Available vacancy:**

The provisional vacancy will be notified in the website of DMET, Odisha i.e. [www.dmetodisha.gov.in](http://www.dmetodisha.gov.in) and is subject to change if occurred or filled up as on the date of counselling. Vacancies occurred after the date of counselling shall be filled up through fresh advertisement.

### **2. Reservation:**

Vacancy based reservation will be applicable as per the guidelines of Govt.

### **3. Age:**

Must be less than 45 years as on the date of joining in the post.

### **4. Eligibility and Qualifications for Senior Residents:**

4.1. For the post of Senior Residents (non academic) in Clinical Departments (Speciality) the candidate must possess MD/MS/DNB/MDS or any Equivalent Degree in concerned discipline applied for or as prescribed by NMC in “Minimum Qualifications for Teachers in Medical Institutions Regulations, 2022” notified or amended from time to time in force.

4.2. All Qualifications as on the date of counseling shall be considered.

4.3. Other eligibility conditions:

4.3.1. The candidate must be a citizen of India.

4.3.2. The candidate must not be continuing or have completed the tenure of three

years as Senior Resident in any Govt Medical College of the State.

4.3.3. The candidate whose service as Senior Resident has been terminated by any govt. Medical College in the state for whatsoever reason will not be considered for re-engagement.

## **5. Eligibility and Qualifications for Tutor:**

5.1. For the post of Tutors as prescribed by NMC in “Minimum Qualifications for Teachers in Medical Institutions Regulations, 2022” from time to time in force.

5.2. All Qualifications as on the date of counseling shall be considered.

5.3. Other eligibility conditions:

5.3.1. The candidate must be a citizen of India.

5.3.2. The candidate must not be continuing as Tutor in any Govt Medical College of the State.

5.3.3. The candidate whose service as Tutor has been terminated by any govt. Medical College in the state for whatsoever reason will not be considered for re-engagement.

**6. Tentative Programme:** The programme shall be notified in the website of DMET, Odisha

## **7. Selection Process:**

Interested candidates shall fill up the google form in the link given in the tentative schedule as a pre-registration process to participate in the walk-in interview. Without pre-registration the candidates will not be allowed to participate in walk in interview. Eligible candidates shall appear personally before the Convener as per schedule and submit the application form attached to this advertisement duly filled in and self-attested photocopy of required documents and color passport photograph. They must bring the original documents for verification. A recruitment fee of Rs. 500/- is to be deposited online at <https://www.onlinesbi.com/sbicollect/icollecthome.htm> . [under Odisha/Govt Department/ DMET Odisha, Convener Selection Committee /Recruitment fee]. Copy of the bank transaction receipt is to be submitted during document verification.

After successful verification of the documents a provisional merit list shall be prepared and notified inviting any grievance to the merit. The grievances if any will be examined and a final merit list will be notified. The candidates will submit the signed option form for confirmation of their acceptance of allotment. The appointment order will be uploaded in website. The final merit list will remain valid for a period of one year or till subsequent advertisement whichever is earlier. Any other related information if required shall be notified by the Convener in the website of DMET, Odisha i.e. [www.dmetodisha.gov.in](http://www.dmetodisha.gov.in) in “Recruitment for Govt. Medical Colleges” section.

N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary /legal action as deemed proper will be initiated against him/her. At the time of document verification / counseling /

choice filling physical presence of the candidate is mandatory and no authorization will be entertained.

- a. Allotment shall be made on the basis of merit and choice. Engagement letter shall be issued in favour of allotted candidates and shall be uploaded in the website of DMET, Odisha.
- b. Selection will be strictly on the basis of merit list prepared on basis of career marks. Weightage for different examinations shall be as under:  
HSC/Matriculation-20% of total percentage of marks secured.  
Intermediate Science-20% of total percentage of marks secured.  
MBBS/BDS/M.Sc Medical examination-60% of total percentage of marks secured.

One mark will be deducted from the total Career Mark for each extra attempt taken to pass the examinations.

- c. In case of tie it will be resolved as follows:  
“The candidate securing more mark in MBBS shall be placed in higher rank. In case of further tie the elderly candidates shall be placed higher in rank to the younger.”
- d. The Selection Authority at their discretion may short-list the merit list to a reasonable number as per available vacancy.
- e. In case the candidate appointed, fails to join in time, then the next candidate in the panel for the subject may be given a chance.
- f. Any clarification / corrigendum / addendum to this advertisement if required shall be issued by the DMET Odisha and shall be final and binding and will be a part of the advertisement.
- g. All communication shall be made through the website of DMET, Odisha i.e. [www.dmetodisha.gov.in](http://www.dmetodisha.gov.in) No Postal/ personal communication will be made.
