RECRUITMENT FOR FILLING UP OF VACANT POSTS OF ASST PROFESSOR IN GMCH PHULBANI AND PMP MCH TALCHER

Eligible candidates are invited to attend the Walk in Interview for the post of Assistant Professors in GMCH PHULBANI AND PMP MCH TALCHER on contractual/deputation basis in view of MCI/NMC urgency. The details of eligibility criteria/ vacancies/ etc. are as under. The direct candidates shall be appointed on contractual basis and the in-service candidates shall be appointed on deputation basis for a maximum period of four years. The candidates who are continuing as faculties in any of the Govt. Medical College of the state, VIMSAR, Burla or AHPGIC, Cuttack, either on contractual / deputation are not eligible to apply. The regular candidates under OMES cadre are not eligible to apply. The faculties whose tenure is terminated for any reason by the appointing authority will be debarred from being selected for a period of next three years.

1. VACANCY & PROGRAMME

The vacancy is provisional and is subject to change as on the date of counselling. Vacancies occurring after the date of counselling shall be filled up through fresh advertisement. The detailed vacancy and tentative programme will be available in the website of DMET Odisha.

2. ELIGIBILITY:

- 2.1 The candidate must be a citizen of India.
- 2.2 Qualification:
- 2.3 The candidate must possess MD/ MS/ DNB or equivalent degree in the concerned discipline from any MCI/NMC approved/ recognized/ permitted Medical Colleges or any other academic qualification with such additional teaching experience in the subject as may be prescribed by the NMC and as per "Teachers Eligibility Qualifications in Medical Institutions Regulations, 2022" and "Guideline for Under Graduate Courses under Establishment of New Medical Institutions, Starting of New Medical Courses, Increase of Seats for Existing Courses & Assessment and Rating Regulations, 2023" of NMC, in force and OMES Rules 2021.

- 2.4 Must have registered himself/ herself under any State Medical Council/ MCI/NMC after obtaining the degree.
- 2.5 The above qualifications must have been obtained on or before the date of counseling/ interview.

3. AGE LIMIT

The upper age limit for candidates on contractual basis shall be less than 69 years as on date of interview (The maximum age up to which one can serve is 70 yrs).

N.B: The date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council only shall be accepted.

4. PROCEDURE OF APPLICATION

Interested candidates shall fill up the google form in the link provided in the Tentative Programme as a pre-registration process to participate in the walk in interview. Without pre-registration the candidates will not be allowed to participate in walk in interview. Candidates shall appear personally before the Convener in the o/o DMET Odisha, as per schedule and submit the application form attached to this advertisement duly filled in and photocopy of required documents and color passport photograph. They must bring the original documents for verification without which the candidature will be invalid. A recruitment fee of Rs. 500/- is to be deposited online at <https://www.onlinesbi.com/sbicollect/icollecthome.htm> . [under Odisha/Govt Department/ DMET Odisha, Convener Selection Committee /Recruitment fee]. Copy of the bank transaction receipt is to be submitted during document verification. After successful verification of the documents a merit list shall be prepared and notified on the spot. Any other information shall be notified by the Convener in the website of DMET, Odisha i.e. www.dmetodisha.gov.in in “Recruitment for Govt. Medical Colleges” section.

N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary /legal action as deemed proper will be initiated against him/her. At the time of document verification / counseling / choice filling physical presence of the candidate is mandatory and no authorization will be entertained.

5. PROCEDURE OF SELECTION

- a. The selection for Assistant Professor shall be as under:
 - i. Selection will be strictly on the basis of merit list prepared on basis of career marks. Weightage for different examinations shall be as under:

HSC/Matriculation- 20% of total percentage of marks secured.
Intermediate Science- 20% of total percentage of marks secured.
MBBS examination- 60% of total percentage of marks secured. (In case the candidate has passed PG in 2016/2017 or afterwards MBBS– 30% and PG – 30%)
 - ii. One mark will be deducted from the total Career Mark for each extra attempt taken to pass the examinations.
 - iii. In case of foreign medical graduates (FMG) the marks secured in the subjects as per the NMC/MCI conducted by NBE shall be taken for calculation of merit as above. Where the candidate does not submit such mark sheet, their marks will be taken as 50%.
 - iv. In case of tie it will be resolved as follows:
 1. “The candidate securing more mark in MBBS shall be placed in higher rank.
 2. In case of further tie the elderly candidates shall be placed higher in rank to the younger.”
- b. The Selection Authority at their discretion may short-list the merit list to a reasonable number as per available vacancy.
- c. In case the candidate appointed to a post, fails to join in time, then the next candidate in the panel for the subject may be given a chance.
- d. All communication shall be made through the website of DMET, Odisha i.e. www.dmetodisha.gov.in. No Postal/ personal communication will be made.
- e. Engagement will be on the basis of merit. Appointment/ Engagement order shall be uploaded in the website of DMET, Odisha, i.e. www.dmetodisha.gov.in. The direct candidates must report before the authority of the institution allotted within seven days of issue of engagement order or as may be instructed in the appointment order and the in-service candidates shall join after obtaining the relieve order from Government.

6. TERMS AND CONDITIONS

All the terms and conditions as per Govt. letters issued from time to time shall be applicable.

- a. The contractual Assistant Professors are entitled for remuneration of Rs. 1,20,000/- per month, In addition to the above, any incentive as may be notified by the Govt. shall be allowed.
- b. The in-service candidates shall be allowed salary at par to the post in which appointed and any incentive as may be notified by Govt. It will be guided as per the Govt letters issued from time to time.
- c. For contractual direct candidates, the engagement shall be purely temporary and on year-to-year tenure basis and may be for a maximum period of four years subject to satisfactory performance. However, the Govt. reserves the right to terminate the services of the faculty with one-month prior notice from either side.
- d. All the communications shall be made through the website of DMET, Odisha and no personal communication shall be made.
- e. Selected candidates have to sign an agreement as per Govt. resolution 8967/H&FW Dt. 25.4.2022.
- f. The candidates who, after being selected, do not join or leave the job without prior notice of one month shall not be considered for subsequent advertisements for three years.
- g. Any addendum or corrigendum if required shall be notified by DMET Odisha, which shall be a part of the advertisement.

- vi. Mark sheets in support of all the aforesaid examinations (i.e. from H.S.C. onwards) passed including fail marks if any.
- vii. Certificate of Registration for Medical Qualifications from State Medical Council (up to date for UG & PG); Those who are registered in other state councils must submit NoC from the concerned council and proof of online application to OCMR

- viii. Chance Certificate of MBBS/MD/MS/DNB is mandatory.
- ix. Teaching Experience certificate from Competent Authority.
- x. No Objection Certificate from Non-Odisha Govt. Employer/Authority
- xi. Photo ID issued by the Govt. authorities i.e. Passport/PAN Card/Voter I card/, AADHAR card.
- xii. If a candidate claims to possess qualification equivalent to the prescribed qualification, the rule/ authority (with number and date) under which it is so treated must be furnished with the application form.
