Admission to Fellowship Programme: January 2025 Session

An Act of Parliament in 1956 established the All India Institute of Medical Sciences (AIIMS) as an autonomous institution of national importance and defined its objectives and functions. By virtue of this Act, the Institute grants its own medical degrees and other academic distinctions. The degrees granted by the Institute under the All India Institute of Medical Sciences Act are recognized medical qualifications for the purpose of the Indian Medical Council Act and notwithstanding anything contained therein, are deemed to be included in the first schedule of that Act, entitling the holders to the same privileges as those attached to the equivalent awards from the recognized Universities of India.

Online applications are invited from Indian Citizens for the admission to the Post-Doctoral Fellowship (PDF) programme for a maximum tenure period of 01(one) year at the AIIMS, Bhubaneswar for the Academic Session January 2025. Candidates who are fulfilling all eligibility criteria as mentioned below may apply through online mode. The candidates who are in service in any Govt. Hospital/ Institutions are required to submit their application through proper channel only. The candidates will not be permitted for Interview if they fail to produce no objection certificate on the day of interview during scrutiny of documents. They may be allowed provisionally only if they produce a certificate of informing to the HOD/Head of Organization of Institute in which they are employed. If it is brought to the notice of authorities at any stage that the candidate had not submitted application through proper channel, then candidature will stand cancelled and in case of selected candidate, services will be terminated immediately.

2. Age Limit:

45 years as on the last date of the receipt of the Online Application.

3. Emoluments:

Rs. 67,700/- as per 7th CPC, Level –11 of the Pay Matrix + NPA plus other usual Allowances as admissible under rules. However, sponsored candidate against Fellowship in Community Medicine will not be paid emoluments.

7. Application Procedure:

- **Candidates who are fulfilling the eligibility criteria must apply through online mode only by visiting Website: aiimshhubaneswar.nic.in (under Recruitment > Recruitment Notice> Online Recruitment). Failing which, the application/s will be rejected and No further communication will be entertained.**
- The applicants shall upload the scanned copies of the following original certificates to online **form** mentioned above:
 - Date of Birth Certificate,
 - Internship Completion Certificate,
 - Qualifying degree (MBBS / BDS / MD / MS / MDS / DNB)
 - Medical registration Certificate,
 - Relevant Category Certificate if any **

 - No Objection Certificate.

Relevant Category Certificate if any **

Criteria for Persons with Bench mark Disabilities (PWBD):

The disability certificate should be signed by a duly constituted and authorized Medical Board of the State or Central Govt. Hospitals/Institutions & countersigned by Medical Superintendent/CMO/Head of Hospital/Institution.

The candidate shall be allowed to join only after medical fitness certification by duly constituted Medical Board. The candidate must possess a valid document certifying his/her physical disability is conforming to judgment of Supreme Court of India. The constitution of the Medical Board will include consultants from related disciplines.

- For OBC Candidate: Candidates must attach certificate valid for the posts under the Central Government of India which mentions that the Candidate does not belong to Creamy Layer.

Date of issue of Certificate should not be earlier than **1 year from the last date of submission of Application Form.**

- Candidates applying in EWS category must possess a valid EWS certificate in Hindi/English Language issued by the competent authority for admission/jobs in central government institutions. EWS certificates must have issued on or after **01.04.2025 to the last date of submission of Application Form** and be valid for **financial year 2025-26**.
- SC, ST, Certificate should be issued by authorities prescribed by Govt. of India.
- *Language of Certificate should be in Hindi/English Language and in prescribed format for central Government.

Note: Candidates are advised to download the filled application form along with the fee receipt after submission of application. The same to be submitted at the time of document verification/Interview.

8. Selection procedure:

- The candidate can apply for more than one post (Maximum 03 departments) out of the enlisted Departments separately as mentioned above but, they have to apply separately for different posts/Departments. However, the candidate will have to deposit application fee separately for each post.
- Written examination will only be conducted when number of applicants are more than three times than the number of posts advertised. However, there will be no written test for the post against which less number of applications are received than the vacancies. Director, AIIMS, Bhubaneswar will have the discretion to decide for which post written examination to be conducted and for which post there will be no written examination. The decision thereof will be final.
- The merit list (selected and waiting list) shall be prepared on the basis of combined marks of written test and personal interview or only Personal Interview as the case may be. No TA/DA will be paid to attend the Interview.
- Any vacancy arising because of non-joining by selected candidates in this selection or by resignation of candidates, post will be offered to the candidates from waiting list according to the merit panel. All applicants must provide latest mobile numbers and e-mail for timely communication.
- For qualification /Selection Procedure/Emolument/date of Interview and other latest details, candidates are advised to visit AIIMS, Bhubaneswar website regularly.
- Selected Candidate will be expected to stay in Institute Campus if offered residential accommodation.
- After filling of available posts of all remaining candidates shall be kept in the waiting list. They must submit two latest phone numbers and email to Academic Section for faster communication.
- Prior experience (research or clinical) in PDF in Critical Care Medicine / Palliative Care Medicine / Minimal Access Surgery and PDF in Diagnostic Neuro Imaging as applicable will be given preference in selection process of upto 5 marks as decided by the committee.
- Candidates working in Govt. / Semi-Govt., PSU should apply through proper channel only. The in-services candidates will not be permitted to join if selected, without “No Objection Certificate” from the employer. In this connection, it is mentioned that as per the terms and conditions of Senior Residency Scheme that their engagement is to be regulated as per the CCS (Temporary Service Rules). As per rule 1(3) of the CCS (TSR) that these rules shall apply to all persons who hold a Civil Post including all civilians paid from defence service estimate under the Govt. of India, and who are under the rule making control of President, but who don't hold a lien or suspended lien on any post under the Govt. of India or State Govt.

9. Terms & Conditions:

- Canvassing information of any kind will lead to disqualification, incomplete applications will not be considered and will be REJECTED. No interim correspondence shall be entertained.
- The prescribed qualification is minimum and merely possessing the same does not entitle any candidate for selection.
- The appointees shall be granted leave in accordance with the instructions issued by the Government of India from time to time.
- Private practice of any type is strictly prohibited.
- He / She may work in shifts and can be posted at any place in the Institute as per the discrimination of the MS/Dean/Executive Director.
- He/ She is expected to abide by the rules of conduct and discipline as applicable to the Institute employees.
- The candidate should not have been convicted by any Court of Law.
- In case, any information given or declaration by the candidate is found to be false or if the candidate has wilfully suppressed any information relevant to this appointment, he/she will be liable to be removed from the service and action will be taken as deemed fit by the Competent Authority.
- The decision of the Competent Authority regarding selection of candidates will be final and no representation will be entertained in this regard.
