This engagement is purely temporary for one semester / one year (Odd / Even Semester) with on a fixed remuneration (as per Government of Odisha norms) per teaching hour. The eligibility criteria is same as for Assistant Professor in the mentioned subjects as laid down in para 4 of UGC regulation 2010 published in Gazette of India (as amended from time to time).
