

IIIT Bhubaneswar Advertisement for Visiting Faculty (Rolling Advertisement)

International Institute of Information Technology Bhubaneswar (IIIT-Bh) was established by the Government of Odisha in 2006 and was converted to a unitary University in 2014. It is designed to be a premier Institute of Information Technology and related areas. IIIT-Bh aims to conduct outcome based higher learning, research, innovation and technology development in the field of Information Technology.

IIIT Bhubaneswar invites applications from eminent academicians, scholars and professionals for short and long term assignments as **visiting faculty**.

Visiting commitments can range from a semester to a year or longer. The nature of the engagement can vary from teaching regular or short courses, conducting seminars or workshops, consulting with faculty for collaborative research or individual projects. The institute is open to applications from Computer Science and Engineering (CSE) and Electronics and Telecommunication (ETC).

Visiting faculty are sought at the level of visiting Assistant Professor, Visiting Associate Professor, visiting Professor for a semester or longer duration. A visiting faculty typically teaches courses at the Institute, most commonly during the regular semester, conducts research and assists in administration.

Eligibility:

- Bachelor's and Master's Degree in Engineering along with a PhD degree in relevant subject area for engineering streams.
- Applicants must have a consistently good academic record with first class or equivalent grade in all preceding degrees in appropriate discipline and demonstrated research potential.
- Retired faculty members from Institutes of repute may also apply for these positions.
- Minimum requirement of qualifications and/or experience may be relaxed for exceptional candidates.

Visiting faculty receives a consolidated monthly honorarium, office space and access to the institute's other facilities.

Application Process:

Applicants are required to send copies of all documents along with their complete bio-data to the Director with the superscription on the envelope as "Application for Visiting Faculty (Department)" to the following address:

- Documents required:
 - o Complete bio-data
 - o Application fee receipt
 - Age proof certificate
 - o Qualification certificates and mark sheets
 - o Category certificate (for age relaxation)
 - Two letters of recommendation (one preferably from the Ph.D. supervisor) for visiting Assistant Professor position
 - o Top three research publications
 - o Statement of purpose (one page write-up showcasing the purpose of applying for this position)
 - o Research proposal (3-4 pages) for three years
 - o Teaching plan for next three years

Application fee:

- General/OBC/EWS Candidates : Rs.1180 (including 18% GST) as applicable
- SC/ST/PWD/Women : Rs. 590(including 18% GST) as applicable

Terms and Conditions:

- 1. Final selection of the candidates will be based on their academic and professional background and performance in the presentation followed by interview.
- 2. The candidates should possess degrees from any recognized University/Institute.
- 3. Initial appointment will be for a maximum period of one year. Extension will be granted based on the evaluation by competent authority.
- 4. Mere eligibility does not vest any right on any candidate for being called for an interview/selection. The decision of the Institute in all matters will be final.
- 5. In addition to his/her academic assignments, the visiting faculty has to perform other duties and activities assigned by the competent authority.
- 6. This is a full time assignment. The rules and conditions governing the number of teaching days and workload shall be as prescribed by the Institute from time to time. Visiting faculty shall attend office on all working days as notified by the Institute to accomplish the tasks assigned.
- 7. The visiting faculty shall be bound to act in conformity with the Statutes, Ordinances, Regulations, and Rules of the Institute.
- 8. The payment of taxes including income tax will be the sole responsibility of the visiting faculty. However, tax reduction at source will be effected against the payable remuneration at applicable rates as per the prevailing laws, rules, and regulations.
- 9. On campus residential accommodation may be provided as per the rules and regulations of the Institute, subject to availability.
- 10. The Institute reserves the right to withdraw any or all the posts advertised.

Performance Assessment during the Tenure:

- 1. The visiting faculty will conform to all the rules and regulations of the institute governing the services of its employees.
- 2. The performance of the visiting faculty will be assessed by a committee constituted by the Institute.
- 3. The subsequent extension of tenure will be based on the recommendation of the committee on his/her performance.
