Applications are invited from eligible Ex-Servicemen not below the rank of Brigadier or of equivalent ranks from Navy or Airforce for appointment in the Post of Secretary in Rajya Sainik Board, Odisha, Bhubaneswar.

In case Brigadier or equivalent rank is not available, Officer of the rank of Colonel or equivalent rank in Navy and Airforce can be considered.

Eligibility Criteria

- Candidates shall be Ex-servicemen officer, retired/ discharged from the Indian Armed Forces or widows/dependents of Ex-servicemen. All eligible ESM officers (in terms of DoPT definition of ESM), who are allowed to register themselves with the Placement agencies of the three Services and Directorate General Resettlement (DGR) shall be considered.
- 2. Candidates must be permanent residents of Odisha and have proficiency in Odia language.
- Candidates must have had a clean record of previous service and good character.
- 4. The age of Ex-Servicemen shall not be more than 60 years as on 01.01.2025.
- Widows/dependents of ESM shall be considered for the post in case of nonavailability of an ESM officer and they should meet the following additional criteria to be eligible for the Post;
 - a. Age: Minimum 55 years as on 01.01.2025,
 - b. <u>Educational Qualification:</u> Post-graduate from a University recognised by Central/State Govt.
 - c. <u>Experience</u>: Should have undertaken duties in post of not less than Director/equivalent in a Central/State Govt. Organisation/PSU and last drawn pay should have been equivalent to at least Pay Level 13 of 7th Central Pay Commission (CPC).
- Tenure of the appointment shall be for a period of five years or up to 65
 years of age, whichever is earlier, subject to satisfactory performance in
 discharging official duties.

- 7. The Salary of Secretary shall be paid in the pattern of last pay minus pension drawn by them (minus MSP) and there shall not be any DA, HRA, etc. as per *Home Department Office Memorandum No. 30256 dated* 17.07.2025.
- 8. The willing & eligible candidates should submit their Bio-data, with supporting documents, to the Special Secretary to Government, Home Department, Government of Odisha, Lok Seva Bhavan, Bhubaneswar on or before 31.08.2025.
- 9. The Candidates should not have availed any other ESM resettlement or employment benefit from DGR or ECHS or RSB/ZSB or any other Govt. employment (under ESM quota). An undertaking to this effect is to be submitted by the candidates. - 10. The re-employment can be terminated at any point of time by the appointing authority for unsatisfactory performance by giving one month's notice. Besides, if any Re-employed Officer desires to resign, he can do so by giving one month's written notice to the competent authority.
