**Sub: Engagement of Guest faculties/ Guest Laboratory Assistants at 33 numbers of Government Polytechnics and Engineering Schools for the Academic Year 2025-26-regarding.**

**Ref: Letter No- 5872 /SDTE, Bhubaneswar ,dated 06.09.2025**

Madam/Sir,

In inviting a reference to the subject cited above, I am to say that as per letter no.5872dtd.06.09.2025of the SD&TE Department, Finance Department, Government of Odisha has concurred engagement of 414 nos of Guest Faculties and 54 nos of Guest laboratory Assistants at 33 nos of Government Polytechnics and Engineering Schools of the State for the AcademicYear 2025-26 with following conditions.

1. Temporary status of engagement in the advertisement as well as in the engagement letter to be clearly mentioned.
2. It must be clearly indicated that the nature of engagement of the Guest faculties and Guest Laboratory Assistants shall be purely temporary and their claim for regularization /extension/re-engagement shall not be entertained. They can be terminated at any time before completion of the Summer semester without assigning any reason thereof.
3. There will be no parity between the regular employees and the Guest Faculties /Guest laboratory Assistants.
4. If the Guest Faculties and Laboratory Assistants agree to the said terms and conditions, then only they should be allowed to join and upon their joining, it would be deemed that they have agreed to the conditions.
5. The engagement of the Guest Faculties and Guest Laboratory Assistants are to be made by the respective Govt Polytechnics and Engineering Schools as per the Annexure-I for the Academic Session 2025-26 only.
6. Guest faculties have totake Theory, Practical and Project classes compulsorily as assigned by the respective department depending upon the requirement.
7. Guest Faculties have to conduct Co-curricular and Extracurricular activities, besides classroomteaching.
8. Guest Faculties will get per period remuneration as per previouslyGovt approved rate.
9. Guest Faculties shall submit undertaking in the format annexed at **Annexure-II**
10. Guest faculties have to join on the specific date or else the order for engagement shall be withdrawn automatically.

11. Guest faculties will put their biometric attendance.

12. The engagement of Guest Faculties will be made as per previous year practice and not through **outsourcing**.

13. Guest faculties will submit their remuneration bill for each month depending upon the workload assigned to him/her by 5<sup>th</sup> of every succeeding month which must be verified by the respective department with the Students' Attendance Register prior to processing of the remuneration bill for making payment.

**Due procedure and utmost care must be followed while selecting Guest faculties/Guest laboratory Assistants.**

In case of posting of Regular Faculty, engagement of Guest faculty shall be cancelled with immediate effect depending upon the prescribed workload in that subject / respective branch.

Approval of the impaneled list of Guest faculties /Guest Laboratory Assistants will be approved by the Governing Body /IMC of the institution.
