Contractual Appointment of Facilitator for conducting DAESI Programme for the year 2025-26

1. The applications are invited by the CDAO-cum-Project Director, ATMA Sundargarh from Agri-Professionals to work as Facilitator in ATMA-Sundargarh District for conducting Diploma in Agricultural Extension Services for Input Dealers (DAESI) programme. The appointment is purely on contractual basis for 01 year and can be renewed based on the performance and target available for next financial year 2026-27. Facilitator will be selected on the following criteria:-

- Graduate/Post graduate in Agriculture/Horticulture with minimum 3 years experience in agriculture and allied sectors. Preference may be given to Agriculture graduates having an experience of around 20 years in Department of Agriculture, SAUs or KVKs with sufficient field experience.
- Regular government employees of the department of Agriculture cannot be recruited as facilitators for organizing the DAESI Programme.
- The candidate should have adequate knowledge about the agricultural activities undertaken in the districts and experience in organizing training programmes.
- The candidates must have good communications skills and should be capable of mobilizing input dealers for DAESI Programme.
- The candidate should be proficient to handle the computers and smart phones independently to manage the documentation and database management of DAESI Programme.

2. The application in prescribed format along with all the enclosures should be submitted by 22.10.2025 in the office of CDAO-Cum-P.D ATMA, Sundargarh by Registered/Speed post or can be submitted personally/hand to hand in the office of Project Director, ATMA, Sundargarh.

3. The interview will be organized on dt 31.10.25 at 4.0 PM in the office of CDAO-CUM-P.D ATMA office, Sundargarh by the constituted committee.

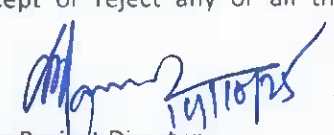

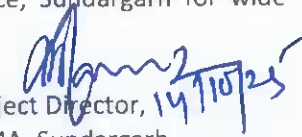
5. The CDAO-Cum-P.D ATMA reserves the right to accept or reject any or all the applications without assigning any reason thereof.

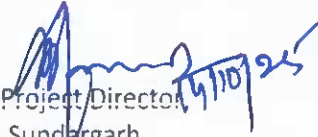
