Degree in Engineering/Technology (regular-full time) in relevant area granted by a recognized/approved University/Institutions in relevant disciplines.

**b) For Diploma Engineering: -**

Three years Diploma in Engineering/Technology (regular-full time) in relevant area granted by a recognized/approved University/Institutions in relevant disciplines.

**c) For Non-Engineering Graduate (BA, B.Sc., B. Com, BCA): -**

He/she must have passed Graduation conducted by any Govt. recognized Board/University within the last 5 years.

**d) For ITI candidates: -**

He/she must have passed ITI qualification in the relevant area conducted by any Govt. recognized Board/University.

- **All candidates must submit duly filled in application form at the time of reporting. The application form is enclosed at Annexure-I.**
- **No candidates will be allowed after the reporting time.**

**GENERAL CONDITIONS: -**

1. Diploma/Engineering Graduate/Non-Engineering Graduate candidates are advised to register their name on NATS 2.0 Portal (<https://nats.education.gov.in>) and ITI candidates are required to register their name on NAPS portal (<https://www.apprenticeshipindia.gov.in>)
2. The candidates aspiring for Apprentice training must get enrolled themselves in the NATS (Diploma/Graduate candidates) /NAPS (ITI candidates) portal within five years after passing their qualifying examination;
3. Candidates who have registered themselves in NATS/NAPS Portal and fulfil the eligibility criteria as indicated above will be considered for appearing in the walk-in-interview.
4. The duration of the training for all the above branches is **one (01) year**.
5. He/she must submit the original College Leaving Certificate (C.L.C.) at the time of joining which will be retained during the tenure of his/her apprenticeship;
6. Candidates should not have work experience of one year or more and not have undergone Apprenticeship training elsewhere & also student should not have completed five years after passing qualifying examination;
7. The original documents including educational qualification, Birth/SSLC certificate, caste, community and experience certificate, etc., in respect of selected candidate will be verified at the time of reporting. Joining at CSIR-IMMT as apprentice trainee is subject to verification of certificates of HSC, +2, ITI, Diploma and Degree and other relevant documents.
8. Based on the performance of the candidates in walk-in-interview, candidates will be selected for undergoing Apprenticeship Training. Engagement letter will be sent to the selected candidates through their email and they have to submit acceptance within 03 days and also join within 07 days after receipt of the engagement letters. If they fail to submit acceptance or joining, their selection shall be treated as cancelled and no further query will be

entertained in the matter;

9. The Selected Candidates will have to make their own arrangement of stay. However, the Institute may provide hostel accommodation as and when vacant hostel accommodation is available.
10. Any corrigendum/addendum/notification etc. or updates with regard to this advertisement shall be made available on our website: <https://www.immt.res.in/>
11. Candidates are advised to regularly visit our website, as all future correspondence and latest information with regard to final result shall be posted on our website. Candidates should mention his/her valid email ID as all communication shall be made through Email ID only as mentioned in the application.
12. Applicant's candidature is provisional and subject to subsequent verification of certificates and testimonials. In case, it is detected at any stage of engagement or thereafter, that a candidate does not fulfil the eligibility norms and/or that he/she has furnished any incorrect/false information/certificate/documents or has suppressed any material fact(s), his/her candidature will stand cancelled. If any of these shortcomings is/are detected even after engagement his/her engagement will liable to be terminated forthwith without giving any notice.

The decision of Competent Authority, CSIR-IMMT, Bhubaneswar will be final and binding on all candidates and on all matters relating to eligibility, acceptance or rejection of the applications, mode of selection, cancellation of the selection process either in part or full, etc. No correspondence/ Interim queries will be entertained in this regard. Filling up of the seats is solely at the discretion of the Competent Authority CSIR-IMMT, Bhubaneswar based on suitability of candidates and no claim will arise for engagement, if some of these seats are not filled due to unsuitability/ insufficient number of candidates.
14. The engagement of students as apprentice trainee is purely temporary for a period of one year only and not for regular employment in CSIR-IMMT. Upon completion of the Apprenticeship period, CSIR-IMMT shall neither have obligation to offer employment to such apprentices nor an Apprentice can claim for employment on the grounds of completion of Apprenticeship.
