Eligibility Criteria:

Ayush doctors (Ayurveda) retired from Central/State Govt. governed by the Old Pension Scheme.

Terms and Conditions for the engagement of retired AYUSH doctors on contractual basis are as under:

1. **Period-**The engagement shall be purely on contractual basis for a period of one year and extendable up to attaining the age of 70 years or till a regular incumbent join, whichever is earlier. Afterwards the contract will cease to exist automatically.
2. **Age-**The engagement shall be up to attaining the age of 70 years.
3. **Remuneration-** Remuneration will be decided on the basis of DOE OM No.03-25/2020-E.III- A dated 09/12/2020. (Pay drawn at the time of retirement minus pension).
4. **Allowance-**A fixed amount as Transport Allowance for the purpose of commuting between residence and place of posting will be allowed as per guidelines of DOE OM No.03-25/2020-E.III-A dated 09/12/2020. TA will be paid as per the rate applicable to the appointee at the time of retirement or Rs.7200/- whichever is less.
5. **Leave-**He/she will be eligible for leave as per the DOE OM No.03-25/2020-E.III-A dated 09/12/2020. Leave of 1.5 days for each completed month of service may be allowed. Accumulation of leave beyond a calendar year is not permitted. In the event of overstay beyond the sanctioned leave his/her contract is liable to be terminated.
6. **TA/DA-**No TA/DA shall be admissible for joining the assignment or on its completion.
7. **NPA-** Non-practicing allowance shall not be admissible. Private practice of any kind is not permitted.
8. **Termination of Agreement:-**
 - a. The doctor is unable to address the assigned works.
 - b. The performance of the doctor is not up to the satisfaction of the department.
 - c. Any false information/declaration furnished or suppression of any fact.
 - d. He/She is found lacking in honesty or integrity.
 - e. In public interest.
 - f. The appointment can also be terminated at any time by either side after giving 7 days' notice or by paying 7 days salary, without assigning any reason by the competent authority.
9. The engagement on contract is a full-time job. Therefore, He/She would not be permitted to take up any other assignment during the period of contract with the ESIC. He/She shall agree and perform all the duties performed by a regular ESIC Medical Officer.

10. He/She should be medically fit for which a medical certificate from a Registered Medical Practitioner having at least MBBS degree will have to be submitted within a week of joining.
11. An undertaking to this effect is to be submitted that he/she has no criminal cases/vigilance cases/ disciplinary cases pending against him/her at the time of engagement.
12. The contractual engagement or renewal thereof, if any shall be governed exclusively by the terms & conditions as stated above.
13. The engagement would only be undertaken after taking approval from ESIC Headquarters, Delhi.
14. The proforma of application for engagement of Retired Ayurveda Medical officers in ESIC Hospital is attached as annexure-I.

1. Certificate of Senior Secondary, 10th/12th grade.
2. BAMS degree certificate

4. Registration Certificate from Central or State registration of Indian System of Medicine. PG degree (if any) also to be registered.
5. Pension payment order(PPO)
6. Government Pensioner's ID card
7. Bank statement or pass book
8. Demand Draft(as applicable)

Instructions to candidates

1. Details of application fee:

By Demand Draft for Rs. 250/- drawn in favour of 'ESIC Fund A/c No.1' payable at SBI Kandasar, Branch.

No application fee in the case of female candidates/PWD. Incomplete application or without prescribed fee/ documents will be rejected. Fee once paid will not be refunded. Successful applicants will be required to execute prescribed contract.

2. No TA/DA will be admissible for 'Walk in interview'.
3. Canvassing in any form shall result in disqualification.
4. In case of selection, the candidate has to enter into an agreement with Medical Superintendent, ESIC Hospital, Angul, on Non-judicial stamp paper of Rs.200/-. Upon joining, the selected candidate has to submit a security deposit of Rs 30,000/- (Rupees Thirty thousand only) as Demand draft in favour of 'ESIC Fund Account No.1' payable at SBI, Kandasar, which is refundable after successful completion of contract and production of 'No dues certificate'
