#### **Minimum Essential Qualifications:**

1. 10<sup>th</sup> + Diploma in (MLT/DMLT/ITI) + Two years experience in relevant field.

2. Graduate Degree in Paramedical and allied Health Sciences - including Medical Laboratory Technology, Assistive Technology, Orthotics Prosthetics, Biomedical Engineering or related.

#### **Desirable:**

Documented Experience to deal directly with patients and their relatives seeking healthcare services.

#### ***Terms & Conditions:***
