

6. No TA/DA will be paid to any candidate to attend the written test/ interview.
7. The candidates are requested to be present 60 minutes before reporting time on the date of written test cum interview for completing necessary official formalities and verification of documents.
8. The selection will be based on academic performance, additional relevant qualifications, research / technology incubation experience and performance in interview.
9. Concealing of facts or canvassing in any form shall lead to cancellation of candidature or termination.
10. The selected candidate will be required to produce all original documents / certificates at the time of joining for verification.
11. The selected candidate will be required to produce medical certificate as per ICAR rules.
