Applications are invited from the interested local residents of Angul Sub-division for selection of 45 nos. of Para Legal Volunteer for the District Legal Services Authority, Angul. The applicants must have the following eligibility for selected as Para Legal Volunteers:

Eligibility Criteria:

1. He/ She must be a citizen of India.
2. He/ She shall be literate, preferably matriculate, with a capacity for overall comprehension.
3. He/ She should be able to speak, read and write Odia language.
4. He/ She should have completed the age of 18 years on the date of Advertisement.
5. Preferably PLVs shall be selected from persons, who do not look up to the income they derive from their services as PLVs, but they should have a mind-set to assist the needy in the society coupled with the compassion, empathy and concern for the upliftment of marginalized and weaker section of the society.

Groups from whom Para-Legal Volunteers can be selected:

- Teacher (including retired teachers)
- Retired Government servants and senior citizens
- M.S.W students and teachers
- Anganwadi Workers
- Doctors/Physicians
- Students & Law Students (till they enroll as lawyers)
- Members of non-political, service oriented NGOs and Clubs
- Members of Women Neighborhood Groups, Maithri Sanghams and other self Help Groups including or marginalized/ vulnerable groups.
- Educated prisoners with good behavior, serving long term sentences in prisons.
- Any other person whom the District Legal Services Authority deems fit to be identified as PLVs.

Disqualifications of Para-Legal Volunteers and their removal:

The PLVs shall be disqualified and removed from the panel if he/she:

- Fail to evince interest in the scheme
- Has been adjudged insolvent
- Has been accused of an offence
- Has become physically or mentally incapable of acting at PLV
- Has so abused his/her position or misconducted in any manner as to render his/her continuance prejudicial to the public interest.
- If he/ she is an active political enthusiast of a Political Party.

Method of Selection:

The Para Legal Volunteers shall be selected through an interview. The Selection Committee is entitled to use its discretion and shortlist the number of candidates for interview depending upon the number of applications received. Preference shall be given to women while selecting PLVs. Representation from suitable applicants belonging to SC/ST, minority and other backward classes must be ensured.

In case of any objection regarding selection of Para Legal Volunteers, the decision of the Chairman, District Legal Services Authority, Angul shall be final and binding on all concerned.

NOTE:-

The work of the PLVs does not carry any salary, remuneration or wages except honorarium fixed from time to time.

Procedure for Submission of Application:

The duly filled application form alongwith self-attested copies of required documents may be submitted to the **Office of District Legal Services Authority, Angul, At-A.D.R Centre, Civil Court premises, Angul, P.O/Dist-Angul, Pin-759122, through Speed Post/ Registered Post or in the Drop Box available in the office of the District Legal Services Authority, Angul by 1.00 P.M. of 13.04.2026 (in any working days)**. The Applicant should mention "Application for the Para legal Volunteer of D.L.S.A, Angul" above the sealed envelope.

If the Applicants so desire, the proforma for Application shall be made available in the Office of District Legal Services Authority, Angul on free of cost. Further, the format of application for empanelment as Para Legal Volunteer for District Legal Services Authority, Angul can be available in the websites angul.dcourts.gov.in and angul.odisha.gov.in. **Any application received after due date & time shall not be considered and shall be summarily rejected.**
