GENERAL TERMS & CONDITION FOR CONTRACTUAL ENGAGEMENT UNDER NHM

MALKANGIRI

1. Applicant must be a citizen of India.

Candidates are required to apply in prescribed format during registration for Walk In Interview as available in the website www.malkangiri.nic.in and to submit along with a set of self-attested copies of all certificates in educational qualification, caste, age, experience, No Objection Certificate from the appointing authority in case of employed & one set of self-attested photocopies of the same and two recent passport size photographs, ID proof (Voter ID/ PAN/ Driving License/ Passport/ AADHAR Card) & Caste certificate issued by the competent authority. Candidate, who are already working in Health Department either on regular or on contractual basis, have to submit No Objection Certificate (NOC) from the employer (appointing authority) at the time of interview, without which they will not be eligible for appearing interview.
