Applications are hereby invited from the interested retired Govt. Employees / Licensed Surveyor / Out-sourced Candidate as per the post category for contractual engagement of different category of 11 nos. of manpower as detailed below in Khordha district for a period of one year. 1. Retired employees who are willing to work in the district of Khordha may submit their applications in the prescribed format (Annexure-I) along with the passport size photograph duly affixed and a copy of the Pension Payment Order.
2. The period of contractual engagement shall not be counted as Government service for the purpose of pension and any other benefit.
3. Licensed Surveyor/ Chainman who are willing to work in the district of Khordha under Revenue Administration may submit their applications in the prescribed format (Annexure-I) along with the passport size photograph duly affixed and a copy of the

Licensed Surveyor / Chainman Certificate and Past Experience Certificate.

4. The contractual engagement shall be initially made for a period of one year or may be extended subject to satisfactory performance and approval of the Government.
5. The amount of remuneration of the contractual employees will be paid as per Finance Deptt. OM No. 24533/F dated. 29.09.2022& Notification No.3920/ dated.01.05.2026 of Labour& ESI Department.

A. Eligibility:

1. Applicant should have retired from the Government service on superannuation or passed from the recognized institute in the same filed.
2. The upper age limit for applying for the post is 65 (Sixty Five)years and the applicant must have attained the age of superannuation on or before 30.04.2026.
3. Applicant should have possessed requisite experience and knowledge of government rules and regulations and should have adequate work experience of aforementioned post in the tabulated format.
4. Applicant should be medically fit and required to submit Medical Fitness Certificate at the time of the engagement.
5. The period of engagement shall be initially for one year or may be extended subject to satisfactory performance and approval of the Government.
6. The engagement is purely temporary & can be terminated at any moment by the Appointing Authority due to unsatisfactory performance. On the contrary if any engaged staff desires to resign he shall do so by giving one month's written notice to the competent authority.
7. Re-employed employees shall be governed by the provisions of Odisha Government Servants' Conduct Rules, 1957 and shall be liable to be proceeded against for their misconduct, omissions and commissions as per the provisions under the Odisha Pension Rules, 1992.
8. Employees against whom departmental proceedings or criminal cases are contemplated/ pending or who have been penalized for misconduct during the period of preceding five years will not be eligible for consideration.

B. Entitlements:

5. No transport facility will be provided for commuting to office.
