Notification No. 01/2026, dated.19.05.2026 filling up of vacant posts of Drug De-Addiction centers in Government General Hospital, Guntur on Temporary basis initially for a period of one year under the control of the Government General Hospital, Guntur.

1. Applications are invited from the eligible candidates for recruitment to various posts of 5 Drug De-Addiction centers in Government General Hospital, Guntur on Temporary basis initially for a period of one year under the control of the Government General Hospital, Guntur.
  - a. Details of recruitment and application will be available in the portal i.e., (<https://guntur.ap.gov.in>) and <http://gunturmedicalcollege.edu.in> from 21.05.2026 to 29.05.2026.
  - b. Applications are invited from 21.05.2026 to 29.05.2026, last Date for submission of filled applications by way of physical/Register Post is 05:00 PM on 29.05.2026. Filled in **Superintendent, Government General Hospital, Guntur**. Candidates are advised to apply as soon as possible without waiting till last date to avoid last hour rush. They are also advised to obtain dated acknowledgement from the counter receiving authority, in proof of their submission of application.
  - c. District Jurisdiction for this recruitment is erstwhile district only and the vacancies at health facilities in these district boundaries shall be considered to be filled. Hence candidates shall apply Guntur District only ( Erstwhile District)

These posts are being filled up on Temporary basis initially for a period of one year.

## 2. Reservations:-

To fill up the vacancies as shown above in Erstwhile Guntur District as per Merit cum RoR under the administrative control of Government General Hospital / Guntur Medical College, Guntur according to the G.O.Ms.No.77, General Administration (Services-D) Dept., Dt:02.08.2023 Govt. of AP and G.O.Ms.No.7, Social Welfare (CV) Dept., Dt:18.04.2025 Govt. of A.P.

3. **AGE:** Upper age limit is 42 years. Age will be reckoned as on 30.04.2026 as per G.O.Ms.No.105 GA (Ser-A) dept., dated.27.09.2021 with relaxations as applicable. Relaxations will be as follows:-

- For SC, ST, BC and EWS candidates: 05 (Five) years.
- For Ex-service Men: 03 (Three) years in addition to the length of service in armed forces.
- For differently abled persons: 10 (Ten) years.

4. **Fee:** The application fees should be paid by the way of Demand Draft only from SBI and UNION Banks in favour of Superintendent, HDS, Government General Hospital, Guntur payable at Guntur. (if candidate is eligible for more than one post needs to enclose paid fee receipt for each post separately) as given below;

- a) For OC candidates Rs.300/-  
b) For BC/EWS candidates Rs.200/-  
c) For SC/ST candidates Rs.100/-  
For Physically challenged candidates Exempted

**5. Weight-age for selection as follows:**

**6. Self attested copies of the application: certificates to be enclosed to the filled in application.**

- SSC or its equivalent.
- Intermediate or its equivalent.
- Pass certificates of qualifications prescribed for the posts concerned.
- Proof of appearance for the qualifying examination where ever applicable.
- Marks memos of all years of qualifying examination or its equivalent. In the absence of marks memos, marks will be calculated as per rules in force.
- Valid certificate of registration and renewal certificates of respective Council Constituted under the relevant rules for specific courses where ever applicable.
- Study Certificates from class IV to X from the school where the candidate studied. In case of private study local candidature certificate for that particular 7 years period preceding to the year of passing X class from competent authority in Form Appendix I certificate of residence prescribed vide Sub clause (ii) of clause (a) of para 7 of the Presidential Order (proforma is herewith enclosed). Candidates migrated from Telangana shall submit certificate of Local candidature as per GO No 132 & 133 dt: 13.06.2017. In the absence of the suitable certificate, the candidate will be considered as non local and further action will be as per rules in force.
- Copy of valid caste certificate (In case of non submission of valid caste certificate, the candidate will be considered as OC).
- Certificate of disability issued in SADAREM.(differently abled candidates will be considered after getting re-assessment from the Board).
- Any other certificates as relevant and applicable.

**Note:- Candidates must submit clear, visible documents (a to j of para.7), failing which application will be summarily rejected. Applications without the above documents will be summarily rejected.**

## **7. Conditions on Appointment:**

The candidate selected and appointed on Contract/ Outsourcing basis shall not be regarded as a member of the service in which the post to which he/she appointed is included and shall not be entitled by reason only of such appointment, to any preferential right to any other appointment in that or any other service. The department or the person may revoke the contractual appointment or discontinue the contract by giving one month notice in writing on the either side. This contract would automatically cease to operate on lapse of contract period and both parties will be discharged of their respective obligations and liabilities without any formal or informal communication.

### **Other important information to candidates:**

- a. If selected, he/she should stay at their bonafide Head Quarters compulsorily.
- b. If selected and appointed he/she should abide rules in force issued by the Government from time to time .
- c. Candidates are advised to follow official website <https://guntur.ap.gov.in> from time to time for further information. (Provisional list, Speaking orders, Final list, Selection list)
- d. All the persons on contract basis shall execute an agreement on a non judicial stamp of Rs.110/- with two witness and submit the same to the appointing authority concerned at the time of reporting for the duty.

## **8. DEBARMENT:**

- a. Candidates should make sure of their eligibility before applying the post and that the declaration made by them in the format of application regarding their eligibility in all aspects. Any candidate furnishing in-correct information or making false declaration regarding his/her eligibility at any stage or suppressing any information is liable to be debarred from recruitment conducted by the department and summarily rejection of their candidature for this recruitment & future recruitment.
- b. The department is vested with duty of conducting recruitment and selection as per rules duly maintaining utmost secrecy and confidentiality in this process and any attempt by any one causing or likely to cause breach of this duty in such manner or such action as to violate or likely to violate the fair practices followed and ensured by the department will be sufficient for rendering such questionable means ground for debarment.

## **9. DEPARTMENT'S DECISION TO BE FINAL**

- a. The decision of the department regarding acceptance or rejection of the candidature, conduct of counselling and at all consequent stages culminating in the selection or otherwise of any candidates shall be final in all respects and binding on all concerned under the powers vested with. The department also reserves its right and modify stages up to selection duly intimating details thereof to all concerned as warranted by any unforeseen circumstances arising during the course of this process.

b. All interested and eligible candidates shall apply after satisfying themselves that they are eligible as per the terms and conditions of this recruitment notification. Any application sent other than physical/register post with acknowledgement will not be entertained under any circumstances. Submission of application form by the candidate is authentication that he/she has read the notification and shall abide by the terms and conditions laid down there under.
