1	Doctor(Fulltime)	MBBS with registration with medical council /medical commission" along with "should undergo training arranged by the MOSJE/NISD within three months of joining the Integrated Rehabilitation Centre for Addicts (IRCA)".
2	Project Coordinator cum Vocational Counselor	Graduate with experience of managing such centers for a minimum period of 3 years (or) demonstrable capability for running such centers and having working knowledge of computers.

3	Counselor or Social Worker/Psychologist	Graduation in social sciences preferably in Social Work/ Psychology with 1-2 years experience in the field and should have knowledge of English as well as one regional language. Preference shall be given to the person holding a Certificate of Training Course in de- addiction counseling from recognized institution.
4	Peer Educator	Should be literate; Ex-drug user with 1-2 years of sobriety. Willing to work among drug using population and having communication skills. Agrees to refrain from using, buying or selling drugs. Ready to work for the prevention of harmful drug use and relapse
5	Ward Boy	Class 8 th pass with experience of working in Hospitals/ Health Care Centers/de-addiction centers
6	Yoga Therapist/Dance/Music/Art Teacher (Part time)	Possessing experience of at least three years In the discipline.
7	Chowkidhar	1.Must have passed 5 th class or its equivalent 2.Must be an Ex-Service man (or) Must have Been trained in civil Defense or as a home guard 3.Must be able to ride a bicycle (Male candidates only are eligible)
8	Housekeeping staff(Full time)	Must have passed 5 th class or its equivalent

Note: • No bonus marks shall be awarded for possessing qualifications higher than the Prescribed qualification for the post.

• Selection to the posts of Ward Boy, Chowkidar, and Housekeeping Staff shall be made purely on the basis of marks obtained in the qualifying academic examination prescribed for the respective posts. For age calculation, Date of birth certificate or 10th class marks list or school leaving certified/ TC shall be considered only.

AGE:- Upper age limit is 42 years. Age will be reckoned as on 01.07.2025 as per G.O.Ms.No.36 GA(SEWR-A) dept.1GA(Ser-A)dept.,dated.04.03.2025 and relaxations will be as follows:-

- a) For SC, ST, BC and EWS candidates: 05(Five) years.
 - b) For Ex-servicemen: 03(Three) years in addition to the length of service in armed forces.
 - c) For differently abled persons: 10(Ten) years.
 - d) Maximum age limit is 52 years with all relaxations put together.
- a. Profroma of application will be available in the portal (www.vizianagaram.nic.in) from 21-05-2026 to 29-05-2026 in between 10:30 Am to 5: 00 pm .Las date for submission of Physical Applications or through post /courier is 5.00PM on 29 .05.2026 .Filled application shall be submitted in the specific counters in office of the Superintendent , Government Teaching General of the Hospital ,Vizianagaram .

- b. Candidates are advised to apply as soon as possible without waiting till the last date to avoid the last hour rush; they are further advised to obtain dated acknowledgment from the receiving authority, in proof of their submission of application.
- c. District Jurisdiction for this recruitment is erstwhile Vizianagaram district only and the vacancies at Drug De -Addiction Center GGH, Vizianagaram in these district boundaries shall be considered to be filled. The candidates of erstwhile Vizianagaram district shall apply only.
- d. *The merit list prepared under this notification shall remain valid for a period of one year from the date of publication of the final merit list, for the purpose of filling up any arising vacancies, if any.
- e. Selection Process shall be made Merit cum Roster.

The Eligible Candidates shall submit the filled in applications along with required self attested Certificates/documents in the following order.

- a) SSC or equivalent certificate / Date of Birth Certificate or its equivalent (for age proof)
- b) Pass certificates of qualifications prescribed for the posts concerned.
- c) Marks Memos of all years of qualifying examination or its equivalent. In the absence of marks memos, marks will be calculated as per rules in force.
- d) Valid Certificate of Registration in A.P. Medical Council constituted under MCI Act/ A.P. Para Medical Board / Allied Health Care Sciences / any other Council constituted under the relevant rules for specific courses wherever applicable.
- e) Latest Caste Certificate in case of SC/ST/BC (with categorization if any) issued by MRO concerned. In the absence of proper certificate, the candidate will be considered as OC candidate.
- f) Latest EWS Certificate issued by the competent authority in case of the EWS Categories.
- g) In case of Physically Challenged person, latest **SADAREM** must be produced .In the absence of proper certificate, the candidate will not be considered as Physically Challenged person.
- h) In case of Ex-servicemen, relevant certificate issued by competent authority should be enclosed. In the absence of proper certificate, the candidate will not be considered as Ex-servicemen.
- i) Study Certificates from class IV to X from the school where the candidate studied. If SSC or its equivalent done by private study, without attending any school, residence certificate from MRO for previous 7 years period preceding to the year of passing X class from competent authority in form Appendix I certificate of residence prescribed vide Sub clause (ii) of clause (a) of part 7 of the presidential order (Proforma appended to this notification). In the absence of the said certificate, the candidate will be considered as Non-Local. Candidates migrated from Telangana shall submit certificate of local candidature as per GO No 132&133 dt: 13.06.2017
- j) Service Certificate from the Controlling Officer concerned (DM&HO/DCHS/Principal of GMC/ Superintendent of GGH/Any competent authority who appointed the applicant), in the Superintendents of Teaching Hospital enclosed prescribed proforma, along with

- k) copy of Appointment Order/ bank statement of Salary for claiming weightage for Contract/outsourcing/honorary service. In the absence of which the candidate will not be given service weightage.
- l) Any other certificates as relevant and applicable.
- m) Demand Draft/Banker Cheque towards application processing fee in favor of “Hospital Development Society, Govt. Teaching General Hospital, Vizianagaram”.
- Candidates must submit clear, visible documents, failing which application will be summarily rejected. Applications without the above documents will be summarily rejected.
 - The application submitted without the required certificates and incomplete applications will be rejected summarily. **Any deletion or inclusion of certificates once submission of application will not be considered.** Only Typographical Mistakes will be considered while publishing the all types of merit lists.
 - Documents submitted after the stipulated time, which have not been submitted along with the Application, will not be considered.
 - The applications received after the stipulated time will be rejected summarily.

Application fee:

Applicant must enclose a Demand Draft/Banker Cheque to the Application towards processing fee as given below, in favor of “**Hospital Development Society, Government Teaching General Hospital, Vizianagaram.**”

- a) OC Candidates:Rs.300/-
- b) SC/ST/BC candidates:Rs.200/-
- c) Physically Challenged candidates: Rs100/-

***The applications received without fee will be rejected summarily.**

METHOD OF SELECTION:

A. Selection Process:

- a) TotalMarks-100.
- b) 75% Marks will be allocated against marks obtained in the qualifying examination i.e., Aggregate of Marks obtained in all the years in the qualifying examination.
- c) Considering of Foreign Degrees for Aggregate of Marks of 75%: (For Doctor(Fulltime) post)
 1. The candidates who have passed the MBBS degree in Foreign Universities, the 75% aggregate marks weightage is given as per the following equivalence formula.
 - a) A -Grade/Excellent -60% \times 75=45
 - b) B -Grade/Good -55% \times 75=41.25

2. The percentage of marks awarded in Foreign Universities, those marks shall be converted as Grades as follows.

Percentage of marks obtained	Converted Grade	Marks to be awarded for recruitment
80%to100%	A Grade	60%X75=45
65%to80%	B Grade	55%X75=41.25
Below65%	C Grade	50%X75=37.50

3. In certain Foreign Universities Degrees shown as academic hours / amount of hours / ECIS Ranks / National grade / Study hours / credits / Grade points GPA/pass. In such cases, where marks are not clearly shown, the Grade C with 50% as maximum marks will be awarded.
4. Marks awarded for languages shall not be considered for weightage of aggregate marks.
- d) Up to 10 marks @ 1.0 mark per completed year after acquiring requisite Qualification as mentioned in the pass certificate. Weightage will be reckoned up to the date of notification as per Govt. Memo no.4274/D1/2013, HM&FW (D1) Dept., dt.10.07.2014.
- e) Weightage up to 15 marks will be given to the candidates who have rendered service in state PSU/State Autonomous Government Organizations and recruited through an open transparent process duly following the ROR on Contract/ Outsourcing basis including COVID-19 service subject to their satisfactory service certified by the competent authority, as per G.O.Rt.No.211, HM&FW (B2) Dept., dt.08.05.2021, G.O.Rt.No.573, HM&FW (B2) Dept.,dt.01.11.2021andG.O.Rt.No.07, HM&FW(B2)Dept.,dt.06.01.2022, Govt.Memo.No.3740784/B2/2020 of HM&FW (B2) Dept., dt.14.02.2022, Circular No.03/CHFW/2022, dt.11.02.2022 of CHFW, AP.

Particulars of weightage:

- (i) @2.5marks per six months in Tribal Area.
(ii) @2.0 marks per six months in Rural Area.
(iii) @1.0markpersixmonthsinUrban Areas.

Based on Covid-19duties:

- (i) @5marks per six months.
(ii) @10marks per one year.
(iii) @15marks per one year six months.

No weightage will be given for the service less than six months for Non-COVID service.

The COVID-19 weightage shall be applicable only to the persons who have appointed and rendered their service exclusively for COVID-19 on Contract/Outsourcing/Honorarium basis by the District Collector or any other competent authority based on orders issued by the Government from time to time and certified by the controlling officers (DMHO/DCHS/Principal of GMC/Superintendent of GGH) to that effect..COVID weightage will be considered on submission of appointment order for COVOID-19 Management, Monthly attendance certificates and Bank statements indication payment of

Tenure of appointment and important conditions:

The tenure for the contract service is initially one year from the date of joining of the post. Further extension of contract is subject to satisfactory service and as per the instructions issued by the Government. The District Selection Committee reserves all the rights to terminate the contract service of any candidate any time with one month notice or as per directions of the Government from time to time.

Important information to candidates:

- A. If selected, he/she should stay at the bonafide Head Quarters compulsorily.
- B. If selected and **appointed** he/she should be abide by the Government rules in force and issued from time to time.
- C. Candidates are advised to follow official website of the District from time to time for further information.

OTHER INSTRUCTIONS:

A. Caste & Community:

- a) The Candidates belonging to BC, SC & ST of other States are not entitled for reservations.
- b) The General Rule 22 of Special representation shall apply to the appointments of these posts subject to various provisions in the relevant Service rules, except in the case of physically handicapped persons.
- c) The reservation to Women will apply as per General Rule.

B. RULE OF RESERVATION TO LOCAL CANDIDATES:

- a. Reservation to the local candidates is applicable as provided in the Rules and as amended from time to time as in force on the date of notification. The candidates claiming reservation as local candidates should enclose the required study certificates (from IV class to X th / SSC) or Residence Certificate as the case may be. Subsequent production of the certificates will not be entertained under any circumstances.
- b. **Definition of local candidate:**
 - i. "Local Candidate" means a candidate for direct recruitment to any a post in relation to that Local area where he/she has studied in Educational Institution(s) for not less than four consecutive academic years prior to and including the year in which he/she appeared for SSC or its equivalent examination. If however ,he/she ha not studied in any educational Institution during the above four years period, it is enough if he/she has resided in that area which is claimed as his/her local area during the above said period.
 - ii. In case the candidate does not fall within the scope of the above, it will be considered if he/she has studied for a period of not less than seven years prior to and inclusive of the year in which he/she has studied for the maximum period out of the said period of seven years and where the period of his/her study in two or more local areas are equal such local area where he/she has studied last (in such local areas) will be taken for determination the local candidature. Similarly, if he/she has not studied during the above said period in any Educational Institution(s) the place of residence during the above period will be taken into consideration and local candidature determined with reference to the maximum period of residence or in the case of equal period where he/she resided last.
 - iii. If the claim for local candidature is based on study, the candidate is required to produce a certificate from the Educational Institution(s) where he/she has studied during the said 4/7 years period. If, however, it is based on residence, a certificate should be submitted which is obtained from an Officer of the Revenue Department not below the rank of

- c. If, however, a candidate has resided in more than one Mandal during the relevant four / Seven years period but within the same District or Zone as the case may be separate Certificate from the Mandal Revenue Officers, exercising jurisdiction have to be obtained in respect of different areas.

Note:

- a. Single certificate, whether of study or residence would sufficient for enabling the candidate to apply a “LOCAL CANDIDATE”
- b. Residence certificate will not be accepted, if a candidate has studied in any Educational institutions up to S.S.C. Or equivalent examination such Candidates have to produce study certificates invariably.
- c. The candidates claiming reservation as Local candidates should enclose the required certificates issued by the concerned authorities. Subsequent production of the certificate will NOT be entertained under any circumstances

SERVICE CONDITIONS:

- a) The candidate selected and appointed on contract basis shall not be regarded as a member of the service in which the post to which he / she is appointed, is included and shall not be entitled by reason only of such appointment in that or any other service. The Department or the person may revoke the contractual appointment or discontinue the contract by giving one month's notice in writing on either side. This contract would automatically cease to operate on lapse of contract period and both parties will be discharged of their respective obligations and liabilities without any formal or informal communication.
- b) No private practice is allowed during the contract period.
- c) All the recruited candidates shall maintain bonafide head quarters.
- d) Department reserves the right to transfer the contractual employees to any other station due to exigencies of work or administrative reasons.
- e) Disciplinary control in accordance with previous of APCS(CCA)Rules, 1991.
- f) All persons appointed on contract basis shall execute an agreement on a Non-Judicial stamp paper of Rs.100/- with two witnesses and submit the same to the Superintendent, Government General Hospital, Vizianagaram at time of reporting for duty agreeing the terms and conditions of the contract.
- g) The appointments are purely on temporary on contract basis and liable for termination at any time.

DEBARMENT:

- a. Candidates should make sure of their eligibility to the post applied for and that the declaration made by them in the format of application regarding their eligibility in all aspects. Any candidate furnishing in-correct information or making false declaration regarding his/her eligibility at any stage or suppressing any information is liable to be debarred from recruitment conducted by the department and summarily rejection of their candidature for this recruitment & future recruitment.
- b. The department is vested with duty of conducting recruitment and selection as per rules duly maintaining utmost secrecy and confidentiality in this process and any attempt by any one causing or likely to cause breach of this duty in such manner or such action as to violate or likely to violate the fair practices followed and ensured by the department will be sufficient for rendering such questionable means ground for debarment.

DEPARTMENT'S DECISION TO BE FINAL:

- a. The decision of the department regarding acceptance or rejection of the candidature, conduct of counseling and at all consequent stages culminating in the selection or otherwise of any candidates shall be final in all respects and binding on all concerned under the powers vested with. The department also reserves its right and modify regarding time and conditions laid down in the notification for conducting the various stages up to selection duly intimating details thereof to all concerned as warranted by any unforeseen circumstances arising during the course of this process. The Vacancies may increased or decreased.
- b. All interested and eligible candidates shall apply after satisfying themselves that they are eligible as per the terms and conditions of this recruitment notification. Any application sent through any mode other than the prescribed off line mode (physical application) will not be entertained under any circumstances. Submission of application form by the candidate is authentication that he / she has read the notification and shall abide by the terms and conditions laid down there under.
