(ii) For posts below the SAG level (i.e., below Level-14 of the Pay Matrix): **Not exceeding 56 years** as on the last date of receipt of applications.

The period of deputation shall be initially for a period of three years or till promotion of the employee in feeder cadre, whichever is earlier, from date of appointment and the same will be regulated as per DoPT guidelines. The period of deputation may be further extended for a total period of three years subject to DoPT Guidelines. Pay will be regulated as per Govt. of India rules.

5. All the posts carry usual allowance as admissible to Central Government Employees of similar status and other allowances sanctioned at AIIMS, Bhopal (M.P.).
