**1.** Applications are invited from the eligible candidates for recruitment to various posts in health institutions of Secondary Health Guntur District under the control of the DCHS, Guntur District on Out sourcing basis.

**a.** Details of recruitment and application will be available in the portal i.e., (<https://guntur.ap.gov.in>) from **01.07.2026 to 10.07.2026 working days**, last Date for submission of filled applications by way of physical/Register Post is **05:00PM on 10.07.2026** . Applications reached after the prescribed last date, whether submitted in person or through post, will not be entertained and shall be summarily rejected. Filled in applications shall be submitted in the specified counters in **O/o DCHS, Opp.Indian Oil Petrol Bunk, Pattabhipuram, Main Road, Guntur-6.** Candidates are advised to apply as soon as possible without waiting till last date to avoid last hour rush. They are also advised to obtain dated acknowledgement from the counter receiving authority, in proof of their submission of application.

**b.** District Jurisdiction for this recruitment is Guntur District only and the vacancies at health facilities in these district boundaries shall be considered to be filled. Hence candidates shall apply at O/o. DCHS, Guntur only.

**c. Local and Non local**→ Applicable as per G.O.Ms.No.45, GA (SPF&MC) Dept., Dt:20.04.2026, applicants who studied from 4<sup>th</sup> to 10<sup>th</sup> under Guntur District in AP are Local and who studied in other districts in AP treated as Non-Local) studied in other states are In-Eligible. who migrated to any part of AP from the State of Telangana with in a period of 3 years from 2nd June 2014 as per G.O.Ms. No. 132 General Administration Dept., Dt.13-6-2016 & G.O.Ms.No.133 General Administration Dept.,

- ii. The Roster points are followed as per the G.O.Ms.No.77 General Administration (GAD) Dept., 02.08.2023.
- iii. Reservations for Scheduled Castes Rules are applicable as per G.O.Ms.No.7 Social Welfare (CV) Dept., Dated:18.04.2025

**4. Educational (Academic, Professional, Technical) qualifications, nature of appointment and remuneration to various posts:**

If the applicant possesses an equivalent qualification to prescribed qualification in this notification, applicant shall enclose a copy of the Government orders to that effect to the application, failing which their application will be rejected.

**5. AGE:** Upper age limit is 42 years. Age will be reckoned as on 30.06.2026 as per G.O.Ms.No.105 GA (Ser-A) dept., dated.27.09.2021 with relaxations as applicable. Relaxations will be as follows:-

- i. For SC, ST, BC and EWS candidates: 05 (Five) years.
- ii. For Ex-service Men: 03 (Three) years in addition to the length of service in armed forces.
- iii. For differently abled persons: 10 (Ten) years.(Max. Age limit is 52 years)

## 6. Weight-age

Contract/Outsourcing weight-age will be awarded as per G.O.Rt.No.211, HM &FW (B2) Dept., Dated:08.05.2021 and G.O.Rt.No.7 HM&FW(B2) Department, Dt.06.01.2022 read with circular no.03/CHFW/2022, dated 11.02.2022 of CH&FW of AP and Memo. No.3740784/B2/2020, Dated:14.02.2022.

Note-1: The maximum weight-age as mentioned at point - (02) for Government service rendered in Tribal/Rural/Urban areas including Covid-19 duties is maximum upto 15 marks as per G.O.Ms.No.211, HM&FW (B2) department, dated.08.05.2021 read with G.O.Rt.No.573, HM&FW (B2) department, dated.01.11.2021 and GO.Rt.No:07, HM&FW(B2)Dept., Dated:06.01.2022.

Note-2: The above Covid-19 shall be applicable only to the persons who have rendered their services for Covid-19 on Outsourcing basis and are appointed by the District Collectors or any other Competent authority exclusively for Covid-19 purpose, based on orders issued by the Government from time to time.

- a. The COVID-19 weightage shall be applicable only to the persons who have rendered their services for COVID-19 on Outsourcing basis and are appointed by the District Collector or any other competent authority based on orders issued by Government from time to time and certified by the controlling officers (DMHO / DCHS/Principal of GMC/Superintendent of GGH) to that effect.

- b.** The candidates claiming service weightage shall submit original Outsourcing service certificate in the enclosed proforma issued by competent authority along with copy of appointment orders (Bank Statements if necessary). Applications without the service certificates as prescribed above will not be considered for service weightage.

**(Note: Certificates taken earlier are valid. If additional period of service is there, fresh certificate to that effect shall be obtained and enclosed)**

**7. Fee:**

Rs.500/- for OC candidates

Rs.300/- for EWS/BC/SC/ST candidates

Exempted for Physically handicapped Candidates

Applicant should pay Application fee by way of Demand Draft **(DD)** in favor of **DCHS, Guntur** and enclose DD along with application. (if candidate is eligible for more than one post needs to enclose DD for each post separately).

**8. Tenure of appointment and important conditions:**

The tenure for the contract/outsourcing posts is initially one year from the date of joining in the post and may be extended for further period as per the instructions issued by the Government from time to time and services of the employee satisfied by the competent authority. The District Selection Committee reserves all the rights to continue/terminate the contract / outsourcing services of any candidate / candidates at any time with one month notice or as per directions of the Government from time to time.

**9. Self attested copies of the certificates to be enclosed to the filled in application:**

- a. SSC or its equivalent (for date of birth).
- b. Pass certificates of qualifications prescribed for the posts concerned.
- c. Proof of appearance for the qualifying examination where ever applicable.
- d. Marks memos of all years of qualifying examination or its equivalent. In the absence of marks memos, marks will be calculated as per rules in force.
- e. Valid certificate of registration in A.P. Para Medical Board/ Allied Health Care sciences / any other council constituted under the relevant rules for specific courses where ever applicable.
- f. Study Certificates from class IV to X from the school where the candidate studied. In case of private study local candidature certificate for that particular 7 years period preceding to the year of passing X class from competent authority in Form Appendix I certificate of residence prescribed vide Sub clause (ii) of clause (a) of para 7 of the Presidential Order (proforma is herewith enclosed). Candidates migrated from Telangana shall submit certificate of Local candidature as per GO No 132 & 133 dt: 13.06.2017. In the absence of the suitable certificate, the candidate will be considered as non local and further action will be as per rules in force.

- g. Copy of valid caste certificate (In case of non submission of valid caste certificate, the candidate will be considered as OC).
- h. Latest (valid) EWS (Economically weaker sections) certificate issued by the competent authority in case of the EWS categories.
- i. Certificate of disability issued in SADAREM. (differently abled candidates will be considered after getting re-assessment from the Board).
- j. Service certificate from the controlling officer concerned (DM&HO/DCHS/ Principals of GMCs / Superintendent of GGH / Any competent authority who appointed the applicant) for claiming weightage for Contract/outsourcing service will be considered as per GO.RT.No.301, HM&FW (B1) Dept., Dt:20.06.2020 in the absence of which the candidate will not be given service weightage (proforma is herewith enclosed).
- k. Any other certificates as relevant and applicable.

**Note:- Candidates must submit clear, visible documents failing which application will be summarily rejected. Applications without the above documents will be summarily rejected.**

**10. Important information to candidates:**

- a. If selected, he/she should stay at their bonafide Head Quarters compulsorily.
- b. If selected and appointed he / she should abide rules in force issued by the Government from time to time.
- c. Candidates are advised to follow official website <https://guntur.ap.gov.in> from time to time for further information.(Provisional list, Speaking orders, Final list, etc.,)

**11. DEBARMENT:**

- a. Candidates should make sure of their eligibility before applying the post and that the declaration made by them in the format of application regarding their eligibility in all aspects. Any candidate furnishing in-correct information or making false declaration regarding his/her eligibility at any stage or suppressing any information is liable to be debarred from recruitment conducted by the department and summarily rejection of their candidature for this recruitment & future recruitment.
- b. The department is vested with duty of conducting recruitment and selection as per rules duly maintaining utmost secrecy and confidentiality in this process and any attempt by any one causing or likely to cause breach of this duty in such manner or such action as to violate or likely to violate the fair practices followed and ensured by the department will be sufficient for rendering such questionable means ground for debarment.

**12. DEPARTMENT'S DECISION TO BE FINAL**

- a. The decision of the department regarding acceptance or rejection of the candidature, conduct of counselling and at all consequent stages culminating in the selection or otherwise of any candidates shall be final in all respects and binding on all concerned under the powers vested with. The department also reserves its right and modify regarding time and conditions laid down in the notification for conducting the various stages up to selection duly intimating details thereof to all concerned as warranted by any unforeseen circumstances arising during the course of this process.

b. All interested and eligible candidates shall apply after satisfying themselves that they are eligible as per the terms and conditions of this recruitment notification. Any application sent other than physical/register post with acknowledgement will not be entertained under any circumstances. Submission of application form by the candidate is authentication that he / she has read the notification and shall abide by the terms and conditions laid down there under.
