Expression of Interested Candidate for Para-legal Volunteers/Adhikar

Mitra of DLSA, Rayagada

Applications are invited from the eligible candidates for empanelment of Para Legal Volunteers/Adhikar Mitras in District legal Services Authority, Rayagada for a period of one year from their date of empanelment through post/by Drop Box kept in the Office of District Legal Services Authority, Rayagada in the prescribed proforma on or before 28.08.2026 by 5.00 P.M.

Eligibility Criteria:

The persons fulfilling the following criteria may apply for selection of Para-Legal Volunteers for District Legal services Authority, Rayagada.

1. Teachers (including retired teachers)
2. Retired Government Servants and senior citizens.
3. Anganwadi Workers.
4. Doctor / Physician.
5. MSW Students and Teachers.
6. Students and Law Students (till they enroll as lawyer).
7. Members of Non-political, Services oriented Non-Governmental Organizations and Clubs.
8. Members of Women Neighbourhood Groups, Maithri Sanghams and other Self Help Group including of marginalized / vulnerable group.
9. Educated prisoners with good behaviour, serving long term sentence in prison.
10. Any other persons whom the District Legal Services Authority deems fit to be identified as Para-Legal Volunteers.

Minimum Educational Qualification

The PLVs shall be literate, preferably matriculate with a capacity for overall comprehension.

Honorarium

The work of Para-Legal Volunteers does not carry any salary, remuneration or wages except honorarium fixed by the NALSA from time to time.

Disqualifications of Para Legal Volunteers and their removal

The Para-Legal Volunteers shall be disqualified and removed from the panel, if he/she:

1. Fails to evince interest in the scheme.
2. Has been adjudged insolvent.
3. Has been accused of an offence.
4. Has become physically or mentally incapable of acting as PLVs.
5. Has so abused his/her position or misconduct in any manner as to render his/her continuance prejudice to the public interest.
6. If he/she is an active political enthusiast of a political party.

Note: 1. A Self declaration by the applicant should be enclosed to the effect that "He/She has no criminal antecedent".

2. No TA/DA will be allowed to the applicants for attending the interview.

3. The Candidates are required to submit the self attested true copy of the required documents enclosed in the application form.

4. The candidates are advised to visit the District Court Rayagada website i.e. <http://rayagada.dcourts.gov.in> from time to time for updates regarding the selection process and notifications.

5. The willing persons fulfilling the above criteria's may submit their application in the prescribed format along with two nos. of pass port size photographs and a self-addressed stamped envelope of required stamp for speed post to the Secretary, District Legal Services Authority, Civil Courts Premises-II, Near Thakkar Bappa Ashram Premises, Rayagada on or before 5.00 P.M. of 28.08.2026. The Applications received after due date shall not be considered.

The authority reserves the right to accept or reject any application without assigning any reason thereof.
