- As per Rc.No.2253/P4/2020, dated 24.07.2025 of the Director of Medical Education, Govt. of Andhra Pradesh, Vijayawada, applications are invited from the eligible and interested candidates through offline for the following post under the control of Addl.DME/Superintendent, Government Teaching General Hospital, Rajamahendravaram purely on temporary and contract basis for a period of one year to work in Alcohol and Drug De-Addiction Centre (ADDC) at GTGH, Rajamahendravaram.

- The interested and eligible candidates should submit their application to the Addl.DME/Superintendent, GTGH, Rajamahendravaram.
- RESERVATIONS:**
Reservations are applicable as per Rule 22 of AP State and Subordinate Services Rules and instructions issued from time to time including BC, SC and ST reservations. As per the G.O.Ms.No.77 General Administration (GAD) Dept., Dated 02.08.2023.
- Age:** Upper age limit is 42 years. Age will be reckoned as on 01.12.2025 as per G.O.Ms.No.105 GA (Ser-A) dept., dated.27.09.2021 with relaxations as applicable. Relaxations will be as follows:
 - For SC, ST, BC and EWS candidates: 05 (Five) years

- b) For Ex-service Men: 03 (Three) years in addition to the length of service in armed forces.
- c) For differently abled persons: 10 (Ten) years.
- d) Maximum age limit is 52 years with all relaxations put together.

5. Application Fee:

Rs.300/- (Rupees Three Hundred Only) should be paid through Demand Draft (DD) in the name of "Hospital Development Society, GTGH, Rajamahendravaram" and submit the same along with the application to this Office.

6. Method of Selection:

- a Total Marks:100
- b 75% will be allocated for aggregate of marks obtained in all the years in qualifying examination or any other equivalent qualification.
- c Up to 10 marks @ 1.0 mark per completed year after acquiring requisite Qualification as mentioned in the pass certificate. Weightage will be reckoned up to date of notification as per Govt. Memo No.4274/D1/2013, HM&FW (D1) Dept., dt.10.07.2014
- d Weightage to contract employment, based on working area:
 - i. @ 2.5 marks per Six Months in Tribal Area
 - ii. @ 2.0 marks per Six Months in Rural Area
 - iii @ 1.0 marks per Six Months in Urban Areas

7. Tenure of Appointment and Important Conditions:

The tenure for the contract/outsourcing posts is initially one year from the date of joining in the post and may be extended for further period as per the instructions issued by the Government from time to time. The District Selection Committee reserves all the rights to terminate the contract / outsourcing services of any candidate / candidates at any time with one month notice or as per directions of the Government from time to time.

8. Self-attested copies of the certificates to be enclosed to the filled in application:

- a. SSC or its equivalent (for date of birth).
- b. Pass certificates of qualifications prescribed for the posts concerned.
- c. Proof of appearance for the qualifying examination where ever applicable.
- d. Marks memos of all years of qualifying examination or its equivalent. In the absence of marks memos, marks will be calculated as per rules in force.
- e. Valid certificate of registration in A.P. Para Medical Board /Allied Health Care sciences / any other council constituted under the relevant rules for specific courses, where ever applicable.
- f. Study Certificates from class IV to X from the school where the candidate studied. In case of private study local candidature certificate for that particular 7 years period preceding to the year of passing X class from competent authority in Form Appendix-I i.e., certificate of residence prescribed vide Sub clause (ii) of clause (a) of Para 7 of the Presidential Order (proforma is herewith enclosed). Candidates migrated from Telangana shall submit certificate of Local candidature as per GO No 132 & 133 dt: 13.06.2017. In the absence of the suitable certificate, the candidate will be considered as non local and further action will be as per rules in force.
- g. Copy of valid latest caste certificate. In case of non submission of valid caste certificate, the candidate will be considered as OC.
- h. Latest EWS (Economically weaker sections) certificate issued by the competent authority in case of the EWS categories.
- k. Any other certificates as relevant and applicable.

Note: Candidates must submit clear, visible self attested documents (a to k of point 8), failing which application will be summarily rejected. Applications without the above documents will be summarily rejected.

9. Important information to candidates:

- a If selected, he/she should stay at the bonafide Head Quarters compulsorily.
- b If selected and appointed he / she should abide to the Government rules in force regularly from time to time.
- c Candidates are advised to follow official website of the District from time to time for further information.

10. Debarment:

- a Candidates should make sure of their eligibility to the post applied for and that the declaration made by them in the format of application regarding their eligibility in all aspects. Any candidate furnishing in-correct information or making false declaration regarding his/her eligibility at any stage or suppressing any information is liable to be debarred from recruitment conducted by the department and summarily rejection of their candidature for this recruitment & future recruitment.
- b The department is vested with duty of conducting recruitment and selection as per rules duly maintaining utmost secrecy and confidentiality in this process and any attempt by any one causing or likely to cause breach of this duty in such manner or such action as to violate or likely to violate the fair practices followed and ensured by the department will be sufficient for rendering such questionable means as ground for debarment.

11. Department's Decision to be final:

- a The decision of the District Selection Committee regarding acceptance or rejection of the candidature, conduct of counseling and at all consequent stages culminating in the selection or otherwise of any candidates shall be final in all respects and binding on all concerned under the powers vested with. The department also reserves its right and modify regarding time and conditions laid down in the notification for conducting the various stages up to selection duly intimating details thereof to all concerned as warranted by any unforeseen circumstances arising during the course of this process.
- b All interested and eligible candidates shall apply after satisfying themselves that they are eligible as per the terms and conditions of this recruitment notification .Any application sent through any mode other than the prescribed offline mode (Physical application) will not be entertained under any circumstances. Submission of application form by the candidate is authenticated that he/ She has read the notification and shall abide by the terms and conditions laid down there under.

Submission of application by post, by Courier or mails, will not be considered.
