1. Applications are invited from the eligible candidates for recruitment to various Paramedical and Supporting Cadres in health institutions in Vizianagaram district under the control of the District Coordinator of Hospital Services, Vizianagaram on Outsourcing basis.
  - a. Proforma of application is available on the portal <https://Vizianagaram.ap.gov.in> from 10:00 AM of 01/07/2026 to 05:00 PM of 10.07.2026.
  - b. Filled in applications in the displayed proforma along with all relevant required documents shall be submitted in the specified counters in O/o. the District Co-ordinator of Hospital Services, Vizianagaram, which is in the 1<sup>st</sup> floor of Government General Hospital, Vizianagaram either in person or by speed post before 5.00 PM of 10.07.2026 for scrutiny. Candidates are advised to apply as soon as possible without waiting till last date to avoid last hour rush. The applications received by post after the due date will not be examined and the department is not responsible for any postal delay. They shall invariably furnish their address and phone number on the closed envelope containing filled in application while sending the

application through speed post. They are further advised to obtain dated acknowledgement from the receiving authority, in proof of their submission of application if submitted physically.

- c. Last Date for submission of applications either physically or by speed post: 05:00 PM of Date. 10.07.2026.
- d. The Merit Lists of this notification are valid for one year from the date of notification for the purpose of filling up of arising vacancies if any.

**2. Educational (Academic, Professional / Technical) qualifications:**

The candidate should possess the prescribed academic / technical /professional qualifications for the post to which he/ she is applying for as on the date of this notification.

**3. RESERVATIONS:**

- i. There will be Vertical Reservations in respect of Scheduled Tribes, Scheduled Castes, Backward Classes and Economically Weaker Sections; and Horizontal Reservations in respect of Women and Persons with Benchmark Disabilities as per Rule 22, 22(A) and 22(B) of A.P. State and Subordinate Service Rules, 1996 as amended vide G.O.Ms.No.77, G.A.(Ser-D) Dept., Dt: 02.08.2023, G.O.Ms.No.03, G.A. (Ser-D) Dept., Dt: 17.01.2024, G.O.Ms.No.7, SW (CV) Dept., Dt: 18.04.2025 and G.O.Ms.No.46, GA (Ser-D) Dept., Dt: 19.04.2025.
- ii. Reservation to the Local candidates is applicable as provided in Article 371-D as per G.O. Ms.No.45, GAD(SPF&MC), Dept, Dated: 20.04.2026; G.O. Ms.No.54, GA(SP&MC) Dept, Dated: 14.05.2026. and rules as amended from time to time and as in force on the date of notification. The candidates claiming reservation as Local candidates should submit the required Study Certificate(s) (from class I to VII Class) OR Residence Certificate for the preceding seven years immediately the date of commencement of the qualifying examination in which he appeared in the proforma prescribed for those candidates who have not studied in any Educational Institutions as the case may be.

#### 4. **AGE:**

Minimum age limit 18 years and upper age limit is 42 years. Age will be reckoned as on 01.07.2026. Relaxations will be as follows as per applicable rules: -

- a. For SC, ST, BC and EWS candidates: 05 (Five) years.
- b. For Ex-service Men shall be allowed to deduct from his age a period of 03 (Three) years in addition to the length of service in rendered by him in armed forces.
- c. For Persons with bench mark Disabilities: 10 (Ten) years.

#### 5. **FEE:**

Applicant must enclose a demand draft towards application processing fee in favour of **District Coordinator of Hospital Services, Vizianagaram payable at Vizianagaram**. If any candidate is applying for more than one post, he/ she is required to submit separate applications for each post duly submitting separate demand drafts for each post along with each application separately as given below;.

- a) **Application Fee Rs. 500/- in respect of OC candidates and Rs.250/- in respect of SC/ST/BC/EWS/ PWDs.**

#### 6. **METHOD OF SELECTION:**

The selection to this Recruitment will be based on the merit given below:

- a. **Following documents to be submitted to claim COVID-19 weightage:**
1. Appointment order for COVID-19 management.
  2. Monthly attendance certificates.
  3. Bank statement indicating payment of monthly remuneration along with COVID-19 weightage service certificate.
  4. Service certificate from the competent authority in the prescribed proforma (DMHO/DCHS/Medical Superintendent in case of GGH/ Principal in case of Government Medical College).
- b. Covid-19 contract weightage will not be awarded in case of non-submission of any of the above certificates from 1 to 4.
- c. The candidates claiming service weightage shall submit original contract / Outsourcing/ Honorarium service certificate in the enclosed proforma issued by the competent authority (DM&HO,DCHS,Principal Medical College or The Superintendent, GGH) along with copy of appointment orders. Applications without the service certificates as prescribed above will not be considered for service weightage.
- d. Contract service will be reckoned up to the date of notification as per Government Memo.no.4274/D1/2013, HM&FW (D1) Dept., dt.10.07.2014.
- e. Spells of services will also be considered for weightage marks if their services were discontinued for want of vacancy and appointed subsequently.
- f. Contract weightage will be awarded as per G.O.Rt.No.211, HM &FW(B2) Dept., Dated 08.05.2021 and G.O.Rt.No.7 HM&FW(B2) Department Dt.06.01.2022 read with circularno.03/CHFW/2022, dated 11.02.2022 of CHFW, A.P.
- g. **Service weightage will be awarded only when experience certificate produced by the individual is in the appropriate cadre only. Experience in any field other than to post applied will summarily be rejected in terms of Memo No.3740784/B2/2020 of the HM&FW (B2) Dept, Dt.14.02.2022.**

**7. TENURE OF APPOINTMENT AND IMPORTANT CONDITIONS:**

The tenure for the outsourcing posts is initially one year from the date of joining in the post or till the post is filled by any other means whichever is earlier. The services may be extended for further period basing on the requirement to the department strictly subject to the satisfactory performance of the incumbent. The District Selection Committee reserves all the rights to terminate the contract / outsourcing services of any candidate / candidates at any time with one month notice or as per directions of the Government from time to time.

**8. DEFINITION OF LOCAL CANDIDATE:**

- i. These categories fall under the district cadre posts as per the Andhra Pradesh Public Employment (Organization of Local Cadres and Regulation of Direct Recruitment) Orders 2025 issued in G.O.Ms.No.45 GA (SPF&MC) dept.20.04.2026 and GO.Ms.No.54, GA(SPF&MC) dept.dt.14.05.2026.
- ii. Local candidature would be considered if he/she has studied in an educational institution or educational institutions in such local area for a period of not less than four consecutive academic years from ending with the academic year in which he/she appeared or, as the case may be, first appeared VII class; or where during the whole or any part of the four consecutive academic years ending with the academic year in which he appeared or as the case may be, first appeared for VII class he/ she has not studied in any educational institution, if he/she has resided in that local area for a period of not less than four years immediately preceding the date of commencement of VII class in which he/she appeared or as the case may be, first appeared.
- iii. In cases where blindness and low vision and, deaf and hard of hearing persons studied in the special schools meant for them, the native place of the parents of such blindness and low vision and deaf and hard of hearing persons.
- iv. Notwithstanding anything contained in this Order, if any Government servant is posted outside the State, the children of the such Government servant studied other than Andhra Pradesh, has right of choosing local area of his or her father or mother or any other area that is chosen by the Government servant, and to that extent a certificate is required from the Competent authority.
- v. The Residence Certificate (for the preceding 7 years period) will not be accepted if a Candidate has studied in any Educational Institutions up to 7<sup>th</sup> class or its equivalent Examination; such candidates have to produce study certificates in variably.

**9. Self-attested copies of the certificates to be enclosed to the filled in application:**

- a. SSC or its equivalent .
- b. Pass certificates of qualifications prescribed for the posts concerned.
- c. Marks memos of all years of qualifying examination or its equivalent. In the absence of marks memos, marks will be calculated as per rules in force.
- d. Valid certificate of registration in A.P. Para Medical

Board/ Allied Health Care sciences / any other council constituted under the relevant rules for specific courses where ever applicable.

- e. Study Certificates from class I to VII from the school where the candidate studied. In case of private study, local candidature certificate for that particular 7 years period preceding to the year of passing 7<sup>th</sup> class from competent authority in Form Appendix I certificate of residence prescribed.
- f. Candidates migrated from Telangana shall submit certificate of Local candidature as per GO No 132 & 133 dt: 13.06.2017. In the absence of the suitable certificate, the candidate will be considered as nonlocal and further action will be as per rules in force.
- g. Copy of valid caste certificate. In case of non submission of valid caste certificate, the candidate will be considered as OC. Applicants belonging to Schedule Classes are required to produce Community Certificate (SC-I, SC-II and SC-III) issued by the Competent Authority of Government of Andhra Pradesh.
- h. Valid EWS (Economically weaker sections) certificate (financial year 2026-2027) issued by the competent authority in case of the EWS categories.
- i. Certificate of disability issued in SADAREM if belongs to PWD category.
- j. Service certificate from the controlling officer concerned (DM&HO/DCHS/ Principals of GMCs / Superintendent of GGH / Any competent authority who appointed the applicant) for claiming weightage for Contract/outsourcing/honorarium service; in the absence of which the candidate will not be given service weightage (proforma is herewith enclosed).
- k. The documents prescribed in para 6 (a) or mandatorily required for claiming covid weightage.
- l. If a person belongs to Ex-serviceman category, certificate regarding the same has to be enclosed and any other certificates as relevant and applicable.
- m. **Note: Candidates must submit clear, visible documents (a to l of para.9), failing which application will be summarily rejected.**

**10. IMPORTANT INFORMATION TO CANDIDATES:**

- a. If any certificates submitted by the candidate are found fake later, his services will be terminated by recovery of his salary and by filing criminal case on the candidate.
- b. If selected, he/she should stay at the bonafide Head Quarters compulsorily.
- c. If selected and appointed he /she should be abide by the Government rules in force regularly from time to time.
- d. Candidates are advised to follow official website <https://Vizianagaram.ap.gov.in> from time to time for further information, as no written communication will be given to each candidate from time to time.
- e. **The District Selection Committee, Vizianagaram reserves every right to cancel the notification at any point of time /alter/ modify any condition laid down in the notification.**
- f. The No. of vacancies now notified is provisional and likely to increase or decrease as per the need of the department at the time of selection and purely subject to the available vacancies after completion of the exercise of the allocation of employees to the newly organized local cadres. Since the process of allocation of posts and the employees has already been initiated, the publication of the merit lists and the selection lists may be done after completion of the exercise by the Government.

**11. DEPARTMENT:**

- b. The department is vested with duty of conducting recruitment and selection as per rules duly maintaining utmost secrecy and confidentiality in this process and any attempt by any one causing or likely to cause breach of this duty in such manner or such action as to violate or likely to violate the fair practices followed and ensured by the department will be sufficient for rendering such questionable means ground for debarment.

**12. DEPARTMENT'S DECISION IS FINAL:**

- a. The decision of the department regarding acceptance or rejection of the candidature, conduct of counselling and at all consequent stages culminating in the selection or otherwise of any candidates, shall be final in all respects and binding on all concerned under the powers vested with. The department also reserves its right and modify regarding time and conditions laid down in the notification for conducting the various stages up to selection duly intimating details thereof to all concerned as warranted by any unforeseen circumstances arising during the course of this process.
- b. **The District Selection Committee, Vizianagaram reserves every right to cancel the notification at any point of time /alter/ modify any condition laid down in the notification.**
- c. All interested and eligible candidates shall apply after satisfying themselves that they are eligible as per the terms and conditions of this recruitment notification. Any application sent through any mode other than the prescribed offline mode (physical application) will not be entertained under any circumstances. Submission of application form by the candidate is authentication that he / she has read the notification and shall abide by the terms and conditions laid down there under.
