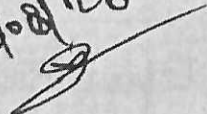

Sir/Madam,

The Finance Committee in its 69th Meeting held on 15.11.2019 recommended the proposal of Enhancement of remuneration to be paid to contract teachers and the same has also been approved by the Executive Committee in its 40th meeting held on 25.02.2021. It has been decided to enhance the consolidated remuneration being paid to the teachers on contract basis as under:

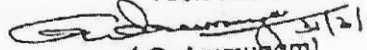

The revised rates will be applicable with effect from 1st April 2021, the day from when new contract for the new academic session may be signed.

The appointment of contractual teachers against regular posts are short term measure in exigencies only. The revised remuneration is payable to the above categories of contract teachers who are fully qualified and engaged by following due selection procedure on full time contract basis against a vacant sanctioned post in a Vidyalaya. All other conditions regarding engagement of teachers on contract basis will remain unchanged.

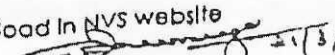
