1. A sum of Rs. 600/- per post/per candidate for Medical Consultant (Male and Female) will have to pay processing fee (non-refundable) in cash at the time of Walk-in-interview.
2. The interested eligible candidates are invited to participate in Walk-in Interview for the said position. The eligible candidates should bring all original certificates and testimonials (for verification) along with one set required at the time of walk-in-interview.
3. Selected candidates shall not claim regular appointment at this University, as the post is ad-hoc in nature.
4. The candidate will have to submit one-month prior notice if he/she desires to leave the present job failing which, he/she will have to surrender one-month salary *in lieu* of the notice period. However, his/her resignation will only be accepted to join other permanent jobs. The candidate will not be allowed to join another assignment during the tenure.
5. The appointing authority reserves all rights to terminate services of the candidate in between the contractual period if he/she fails to perform desired result/output without giving any reason and notice and the decision of the appointing authority will be final.
6. The University reserves the right to reject one or all the applications without any reasons thereof.
7. The Post is purely temporary and will be filled on contractual basis for eleven-months period.
