Recruitment Notice for Non-Teaching Contractual Positions of Student Counsellor

The applications are to be filled Online Only through the Recruitment Portal of the Institute.

Indian Institute of Information Technology, Nagpur (IIITN) is one of the 20 Indian Institutes of Information Technology established under Public-Private Partnership Scheme by Ministry of Education (MoE), Government of India. IIITN has been declared as an “**Institution of National Importance**” under the provisions of IIIT (PPP) Act, 2017 and at present the Institute is functioning under Department of Higher Education, Ministry of Education and is supported by Department of Higher Education, Government of Maharashtra, Tata Consultancy Services, Mumbai and Haldiram’s, Nagpur as Industry Partner.

IIIT, Nagpur is offering Under Graduate and PhD Programs in Computer Science & Engineering (CSE), Electronics & Communication Engineering (ECE) and Basic Sciences (BS), Artificial Intelligence & Machine Learning, Data Science & Analytics, Human Computer Interaction & Gaming Technology and Internet of Things.

The Institute is located at a distance of about 25 Kms from the Nagpur City at Sr. No. 140,141/1 Behind Br. Sheshrao Wankhade Shetkari Sahkari Soot Girni, Village - Waranga, PO - Dongargaon (Butibori), District - Nagpur (Maharashtra) – 441108.

The Institute invites applications from eligible candidates for the following Non-Teaching Contractual Positions:

1. Name of the Post: Student Counsellor – Two Post (01 Male and 01 Female)

Job Description: The job would involve active counseling of students largely in the 18-28 age groups as well as adults of above 28 age, organisational work in connection with developing a suitable counseling programme for students and liaison work with professional volunteer agencies and hospitals for the benefit of the student population of the Institute.

The Counsellor would be the point of contact for student if they require interpersonal/ emotional counseling.

The Counsellor will maintain confidentiality but shall report to the Competent Authority of any extreme case that demand Institution/ Family intervention.

The Counsellor shall conduct workshops, talks and group discussions from time to time to help the students with their academic, interpersonal and emotional needs.

He / She would also have to execute various administrative tasks related to any other Administrative Section as and when required. Proficiency in computer operations is a must.

Desirable: Additional qualification in Mental Health or Counselling.

Reporting to: Associate Dean Student Welfare, Registrar or as advised by the Competent Authority from time to time.

TERMS & CONDITIONS

1. The Counsellor shall visit the Institute from Monday to Saturday (09:30 AM to 6 PM) or as decided by competent authority.
2. The Counsellor will be available for consultation in case of emergency during holidays/odd hours as per the requirement of the Institute.
3. In case of a pandemic like COVID-19 if a lockdown/ curfew is imposed by the Central/State Govt. the Counsellor will have to provide/conduct online counselling through an online platform to the students/staff of the institute.
4. The Counsellor shall maintain a database of the mental well-being of the student/employees.

QUALIFICATION & EXPERIENCE:

Essential: B.A/B.Sc. (Psychology) with certificate of Diploma in Counselling with minimum of Three-Year Experience in providing counselling to students at Educational Institutes.

OR

M.A/M.Sc. (Psychology) with minimum of Two Year Experience in providing counselling to students at Educational Institutes.

OR

MBBS with Master's/Diploma in Psychiatric Medicine, with minimum of One-Year Experience in providing counselling to students at Educational Institutes.

Experience in Educational Institute of national repute like IITs / NITs / IIITs will be a distinct advantage. The candidate should be able to work independently and should have excellent communication and interpersonal skills and multi-tasking abilities. A good oral and written communication skill in English / Hindi is essential.

Remuneration: Rs. 60,000/- Per Month. (Consolidated)

General Information and Instructions to Applicants:

1. The positions are purely temporary & contractual in nature for a period of 11 Months with provision for subsequent extensions as per Institute Policy subject to performance. Decision of the Director shall be final in all respect.
2. The Institute reserves the right to reject any /all application(s) and/or cancel the advertisement in whole or in part without citing any reason at any stage of processing.
3. The Institute reserves the right to increase or decrease the number of posts to be filled as per the sole discretion of the Director.
4. No TA/DA and/or Lodging/Boarding will be paid for attending the Interview.
5. Accommodation shall be provided for attending the interview on "First cum First" and paid basis subject to availability. 9. **The Candidate will have to bring the original documents along with one complete set of self-attested photocopies of the Online Application and supporting documents at the time of interview for verification.**

At the time of verification of documents, if documents are not as per Institute's criteria or originals are not presented then candidate will not be allowed to attend Interview / selection shall be cancelled. Hiding information or submitting false information will lead to cancellation of candidature at any stage of recruitment.
11. All qualification, experience and age limit will be recognized as on the closing date of receipt of the application.
12. **The Institute reserves the right to set higher norms than minimum while short listing taking into account the specific requirements of the Institute.
